SUBJECT: Unidentified Flying Objects

23 July 64

TO: Foreign Technology Division

1. This UFO was reported by Mrs. [REDACTED] of Texarkana, Texas.
2. The objects that were reported were round and approximately the size of an orange (1) and ping pong balls(3).
3. The reported color of the objects was that they were only white blurs.
4. The number of reported UFO's were four, which had no formation, details, exhaust, sound, or special features.
5. The reason that Mrs. [REDACTED] gave for noticing these objects was that she was sitting in her yard relaxing.
6. The approximate angle of elevation was forty-five degrees(45°) of the unidentified flying objects.
7. The flight path of the first three (3) sighted objects was in a south-easterly direction, the fourth(4) sighted object was going from East to West.
8. The first (3) objects disappeared while Mrs. [REDACTED] was reporting them, but the fourth (4) object disappeared over the horizon.
9. The approximate length of time that these four(4) objects were in sight was one (1) minute.
10. The manner that Mrs. [REDACTED] observed these objects was visual and with no optical aids.
11. The time that the UFO's were observed was at 0240Z at dusk on 14 July 1964 at 332550°N 935720°W. (Lakeshore Drive, Texarkana).
12. The name of the person reporting this incident was Mrs. [REDACTED], age 29, her occupation is housewife, and her mailing address is Route 2, [REDACTED], Texarkana, Texas.

13. In my opinion, the information that Mrs. [REDACTED] submitted is unreliable.
