COMMENTS: Three objects observed in September 1964, reported to the Air Force in letter form in May 1965. Too old to investigate. Sighting is characteristic of a misinterpretation of an Astro Body such as a star/planet if the motion is confined to a small area of the sky. Possible a/c activity included. Insufficient data for an evaluation.

Gentlemen:

On September 4, 1964 a LIFU was spotted in Brookfield, Mass., above Lake Quabog. Witnesses were:

[redacted] and [redacted] of Pine Lane in Brookfield, Mass.,

and myself ([redacted]).

The LIFU (seen clearly through binoculars) was completely red, oval shaped, a ring around it and a pole coming from the top of it.

Without binoculars it looked only like a bright red speck in the sky. It seemed to fly at high speed and after circling the lake a couple of times it returned with another LIFU. After they circled a couple of times they later came back with a third, then seemed to disappear faintly.
