Dear Major:

I am enclosing a copy of a letter from the Smithsonian giving the objects aloft which are brighter than magnitude three (3). Could you ask Marilyn to toast a copy for me? I am not near our machine now. As you see, there are eleven (11) objects that are of magnitude one (1) or brighter.

I would like to report also on my visit to O'Hare Air Force Squadron. I had a long discussion with Major Dellaorto and he warmed up to the problem after awhile. I discussed with him at length the Air Force's problem and gave him examples of good reports and bad reports, pointing out that many of our unknowns or insufficient information cases would have been solved if more information had been immediately available. I think he understands now the importance of our statistics, and that far greater detail must be supplied with his reports.

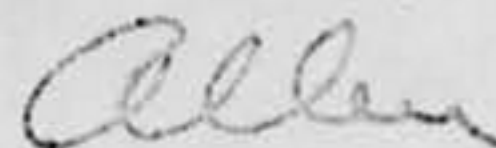
He said he had not the least idea that this matter was so important and tended to blame the Air Force for lack of communication. He said he had never received any information as to the progress of the program, nor did he have any questionnaire forms. He made a suggestion which might have something to it: how about a "UFO newsletter", sent to air bases on an occasional basis. I pointed out that the fact sheet basically served this purpose, but he still felt that an inter-office type of memo aimed at the investigators and not at the public would be of tremendous help.

I think the idea has possibilities, especially if the newsletter could contain an account of a particular ~~setting~~ which was solved because of quick action on the part of the air base to which it was reported. In short, some praise as well as criticism.

I think Dellaorto's key words might be taken to heart: "I didn't know anyone took this seriously."

I forgot to ask you how your new son is getting on. But I assume that everything is just fine.
