The following was extracted from the SSD Staff Duty Officer's Report for the period 1630 14 Feb 65 to 0800 15 Feb 65:

At 2315, a [REDACTED] St, Costa Mesa called requesting AF assistance. Her son, [REDACTED] age 16, had been hiking/camping in the Mt Palomar vicinity on the night of 13 Feb (Sat) with 4 (?) other boys when they spotted an intensive, highly concentrated beam of light. The light source in addition was emitting some type of audible signal. When the boys approached the light, it turned directly in their faces with the light source seemingly tailing them as they attempt to depart the scene of initial contact. They turned and fired a few rounds of ammunition at it from the small arms they carried. The source seemed to be a ground location and it was doubtful that it can be categorized in the UFO.

[REDACTED] husband is a Navy enlisted man at San Diego and advised her to contact authorities. She phoned the FBI who put her in touch with AFSSD. As SDO I contacted a Capt Reichmuth (Foreign Tech) at the suggestion of the CPC NCO. Capt Reichmuth further suggested I turn the matter over to the PID Office. Request necessary action be taken to inform the PID of the incident in order that [REDACTED] be called back. (She asked that she be contacted) Her number at work is [REDACTED] (8:30 - 12:30). Her home phone is [REDACTED]
