Solid object sharply outlined, erratic motion which included stationary portion and sudden burst of speed. Hovering occupied about 1 minute of the observation at which time the object disappeared by ascending into space until no longer visible. View blocked by building. Speed estimated at 800-900 mph. Distance from observer 300 yds. Initial observation at 50 deg elevation in SW flight moving to 90 deg elevation in NE. Initial flight in descent. Hover, then gained in altitude. COMMENTS: Probable a/c observation. No data presented to indicate that the sighting could NOT have been caused by an a/c. Hovering considered an illusion. Witness concept of distance and angles of elevation as well as duration vague and inconsistent conflicting data. If there was an actual object that instigated the report it is likely that an a/c was the cause.

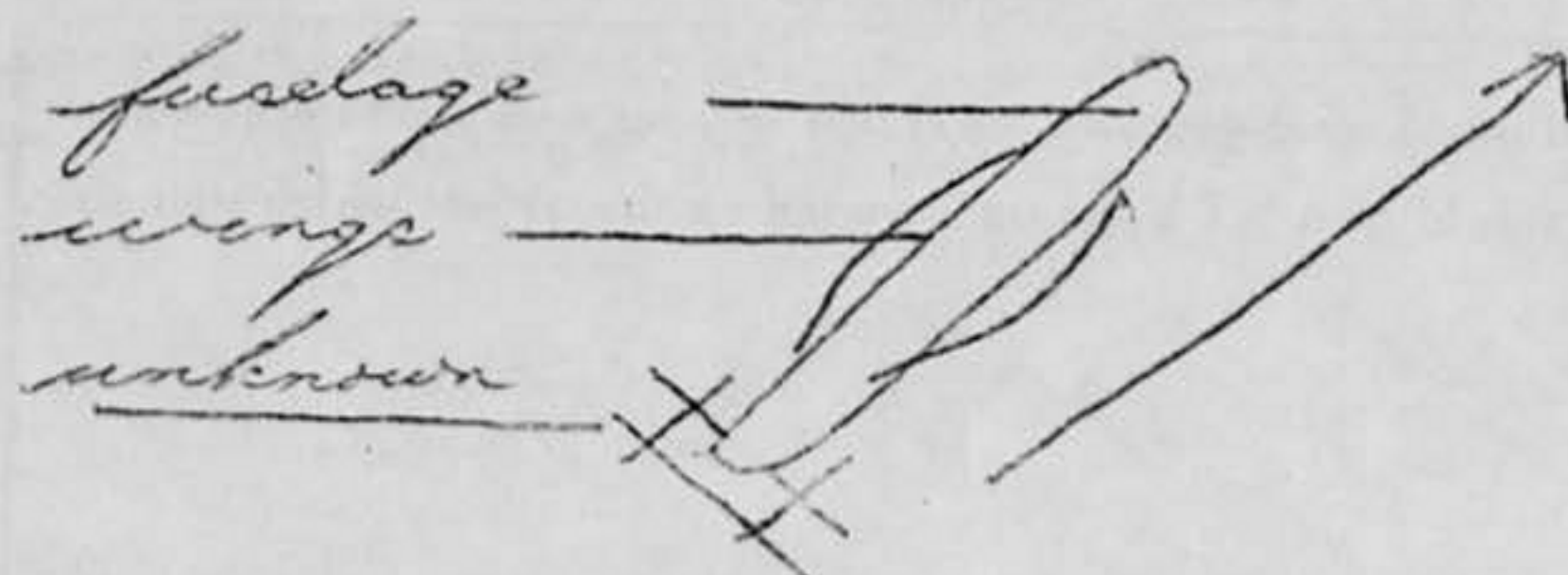

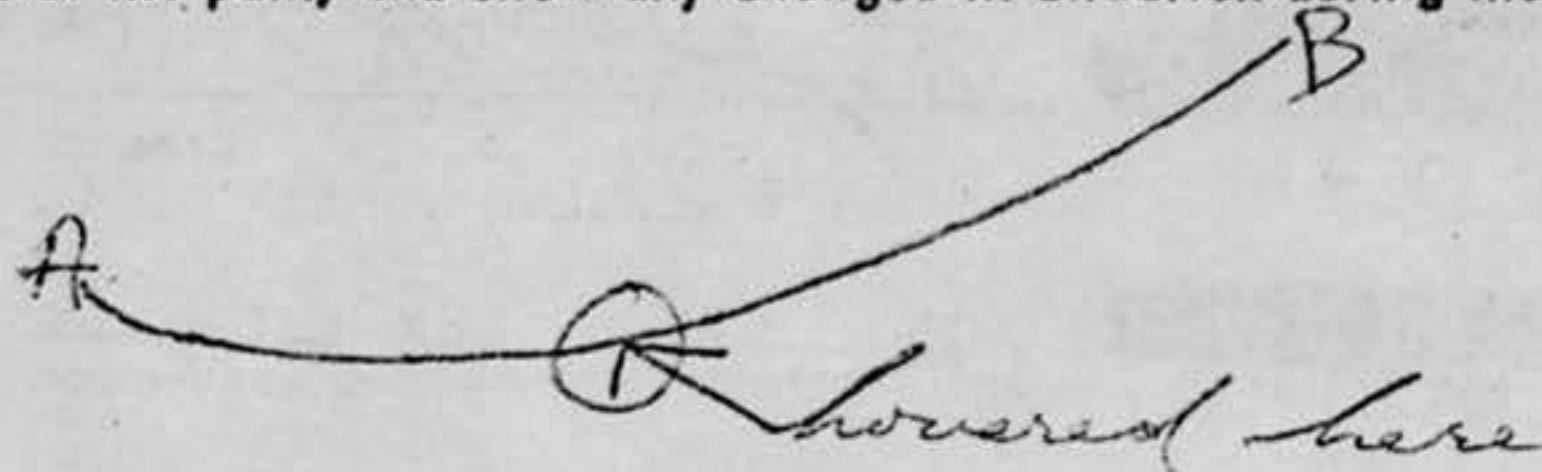

35. Information which you feel pertinent and which is not adequately covered in the specific points of the questionnaire or a narrative explanation of your sighting.

At approximately 3:30 p.m. on February 15, 1965, I was in the parking lot adjacent to Prince George's Plaza, when I happened to look up. At this time I saw the object. It was moving at great speed, and descending. It then hovered in mid-air, for approximately one minute. I did not notice whether or not the craft had windows of any kind. There were several other people in the parking lot, at least one of which saw it. It was a woman with a small child. After hovering for about a minute, the object ascended. The last I saw of it, it disappeared behind the Federal Building which, from my angle of vision, obstructed it. The most curious factors about the craft were: the fact that it did not accelerate and decelerate gradually, but simply took off. If there was any acceleration or deceleration process, it was too ~~fast~~ ^{subtle} for me to notice it. The second was its extreme size; it appeared to be approximately 4 or 5 times larger than a passenger jet. There was no insignia of any kind.
