5. LENGTH OF OBSERVATION Not Reported	11. BRIEF SUMMARY AND ANALYSIS Witnesses watch sky in pursuit of hobby and observed a glowing disc moving across the sky. Too fast for Satellite, no blinkers. Observed in Western sky. Too slow for meteor. Not ECHO because ECHO was due next morning. COMMENTS: Witnesses reported on what object was NOT rather than giving data for identification. Significant that a/c and satellites were mentioned. Pegasus passed over at 1946 about 1/2 hour later and ECHO II went by at 1857 about 18 minutes earlier. Possible that ECHO II was observed but more likely the sighting was triggered by an a/c observation. Speed of too fast for satellite to slow for meteor (apparent speed) is consistent with a/c observation. Lack of flashing light does not eliminate a/c as a cause of observation. Possible aircraft.
