Dear Major Quintanilla:

I would like to call to your attention an interesting object I observed flying fairly low in the sky (at perhaps 1000 feet) within 1/4 to 1/3 of a mile from me on the night of April 15th at about 7:30 P.M. CST.

I was traveling alone east on Plum Tree Road in the Village of Barrington Hills when this brilliant white light (reminded me of magnesium burning in my chemistry class days) attracted my attention. It was moving in a Northerly direction and passed over Plum Tree Road within 1/4 mile in front of my car. I turned off my car radio, dash lights, and opened the window. This object made no sound. I then proceeded on another 100 or 200 feet--watching this light all the time--and turned off my ignition switch and head lights. I could still hear no sound coming from the source of the light. This light was coming from what appeared to be an exhaust, and when I first saw it it was a full and heavy exhaust--that is large in shape and dense--it was shaped like this: $\begin{matrix} B & W \\ \text{---} & \text{---} \end{matrix}$ (Key) B- Blue W-White) It was an extremely brilliant white except $\begin{matrix} B & W \\ \text{---} & \text{---} \end{matrix}$ on the outer edge close to its source there was a vibrant beautiful blue. After passing over Plum Tree Road, it stopped and hovered over a farm field, still about 1/4 mile from me, and I continued to observe it, only this time from my open car window on my left. As I watched, the light dimmed down and finally completely out. During the last stages of dimming out, the light reflected on glass that appeared to be covering some sort of lights (such as the rounded glass on our auto head lights) there was no light coming from these "lights"--only the reflection on the glass coming from the dimming exhaust. These "lights" were on each side of the source of the dimming exhaust. Because of the position of the lights, I had the feeling that the back of this object was curved. Then the object completely disappeared. Except for the reflection in the glass, I saw nothing else but the exhaust. There was a full moon that night--and clouds very high in the sky. The lower sky was clear, and visibility was excellent.

I reported my observations to the Illinois State Police at Elgin that night. I did not know until yesterday that I should have notified you. If you have any further questions regarding this matter, I will be most happy to cooperate with you.

Dear Sirs:

I'm reporting an UFO that I saw April 15, 1965, at 7:35 pm on a farm south-east of Durand, Ill. I thought at first that I was seeing a meteor because of its silence. Then I thought it was a jet in trouble (its speed could have been that of a jet) and it was flying very low, a couple of hundred feet perhaps.

As it cleared some trees I saw jets of flame coming from behind--but no sound! It seemed to be about a mile or less from me in the eastern sky. The best way to describe it would be with a sketch which I am enclosing. I'm not at all sure of the dark area in front of the fire jets but there definitely were the slits that were redish orange. The moon was bright which I think gave the whitish outline to the fire part.

I saw this object for about the count of 5 or 8 seconds then it vanished as it went back of a wooded area. I'm not a person given to "seeing things" nor having visions, but I'll have to admit that I found myself not believing my eyes on that one!

OF FIRE. . . SAW FOR ABOUT 5-8 SECONDS" Object then faded as it went back of
a wooded area. Observation of meteor was low in the Eastern Sky. Dr [REDACTED]
said this was a meteor observation from all information contained in her letter.
Her letter also contained a sketch of the meteor. He said it wasn't a good
sketch but then when people who are not familiar with this type of observation
do not make very good reports and sketches. [REDACTED] said that he would send
this report to us for reproduction and then we could return it to him, there was
no hurry in returning it though, he said. He said usually he does not receive
reports for several months after an observation was made. Said the letter from
Mrs English was not dated, he said the date of the letter is helpful a lot of
times and just doesn't understand why more people don't date their letters.

Thursday evening, April 15, 5 students were playing basketball at the Breeze residence in Pecatonica. The sun had just gone down and it was beginning to get quite dark. Around 7:30 p.m., a bright object appeared $\frac{1}{2}$ to $\frac{3}{4}$ mile to the northeast and was rapidly moving to the NNW. It was observed for about four seconds by the 5 high school students mentioned above. It was described as very bright with a light green color near the center and darker at the edge. It was oval in shape with a short fiery tail, reddish in color. It appeared about 30 degrees above the horizon. Its size was about $\frac{1}{2}$ that of a full moon. The moon was visible at the time through scattered clouds in the ESE sky. The object seemed to disappear in mid air, as rapidly as it had appeared.

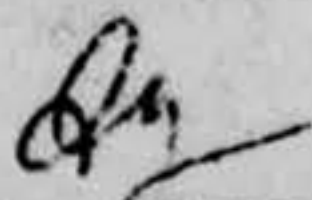
