LADDER LIKE TAIL WITH THREE RUNGS THAT WERE LIT UP. ALSO
IT SEEMED TO BE FURTHER AWAY THAN ON INITIAL PASSES,
HEADING IN THE OPPOSITE DIRECTION AND AT ITS HIGHEST
ANGLE ABOVE THE HORIZON.
