We have received a letter from [REDACTED], Rt 3, [REDACTED], Piedmont, Alabama, requesting identification of an object which she observed on the night of 4 May 65. The letter stated that the object rose from the north-western sky to a point directly overhead and proceeded to settle in the west. This object resembled a satellite. If her letter was in error regarding the disappearance and the object actually disappeared to the southeast, then in all probability the object was ECHO I. This satellite was over Alabama at 08:02 pm, at a high elevation angle. If Miss Chambers does not feel that the object was ECHO I, she should fill out an FTD Form 164 and return it to your office.
