Dear Sir:

On Friday, July 2, at about 11:15 p.m. we watched an unusual object that resembled a star. It was alternately reddish and white. At times it appeared to be the brightest object in the sky and at other times it was hardly visible. It wavered or zig-zagged several times and also appeared to hold steady on occasions. We viewed it for approximately 15 minutes. We first noticed it in the west moving northeast. It changed course three times. When it reached due north it changed course and traveled in a northerly direction. It again changed course and traveled north east. It then appeared to travel south east and disappeared over the mountain.

During this time we phoned another person, Mr. [REDACTED], and he also saw it for about 3 to 5 minutes.

We live in a mountain valley, 65 miles north of Albuquerque, New Mexico. We are surrounded by mountains and the object first appeared over the western range and disappeared over the eastern range.

Since that time, we have been watching the newspapers in hopes of finding an article concerning the object we saw. The article finally appeared in the July 8 issue of the ALBUQUERQUE JOURNAL. But, the article states that you viewed the object Monday, July 5.

We felt our sighting of a similar object might be of interest to you.
