Mr. [REDACTED] contacted police headquarters and stated that he had observed an object like a ball of light, silver in color, with a long vapor trail, approximately the size of a dime, traveling in a northwesterly direction, at approximately the altitude of 5,000 feet. Mr. [REDACTED] stated the object was visible for 4 minutes and disappeared. Sighting was made visually at 0545 hours, 4 August 1965. Mr. [REDACTED] also stated that the object was also sighted by a Mr. [REDACTED], 805 K St., Clunie Hotel, Sacramento, California.
