The Star ARCTURUS was in the West at 20 deg elevation and would appear to move lower and to the North from 280 deg azimuth at 2200 to the horizon at 295 deg azimuth two hours later. Disappearance coincides with the setting of this star. The colors reported are also in accord with this analysis.

[REDACTED] contacted police headquarters and stated, that he, his mother, sister and 3 neighbors had observed two bright objects which appeared to be like stars, traveling at a very high altitude; #1 traveling northwest, #2 traveling northeast. The object changed from red to bluish green to a brilliant white, faded for a second then came back. David Williams stated the object was visible for approximately 2 hours. The object was ground visual without any optical aids.
