Dear Bernie:

This letter is merely for the purpose of allowing you, based on your knowledge of me, to evaluate some of the reports that have been coming out on unidentified flying objects.

At approximately 11:45 last night my fourteen year old son, [REDACTED], having just returned from work at The Broken Bit, had gone to bed on our deck at our home in Oakhurst. Some five minutes later I went out to talk to him briefly and noticed to the southwest a star which appeared to be unusually red -- so much so that I called it to his attention and we watched it to see whether or not it was moving and thus would be classified as a satellite. It did not appear to move and we passed it off with the conclusion that it was simply the winking that made it appear unusually red.

At 11:55 David came in the house and said that it had moved behind the tree. I thought he was mistaken and was prepared to kid him about his imagination getting the best of him but did go and look. It had moved so that it was no longer visible where we had first seen it, but we were able to locate it further to the southwest. My wife, Betty, came to see what we were doing and she observed it but felt that it was an ordinary satellite such as we have observed on several previous occasions during the past years. However, at her suggestion, I did get my deer rifle which has a Redfield telescopic sight which when set on maximum magnifies to nine power.

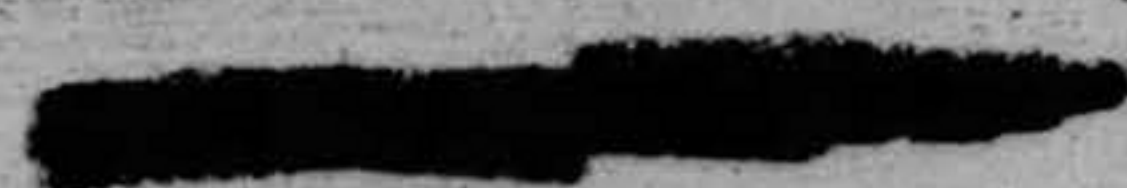

Upon observing the star or satellite thusly it became immediately apparent that it was nothing such as we had ever seen before. As we viewed it, all of the lights, as hereafter described, were on the right side commencing at a point, if it were the face of a clock, at 1:00 o'clock as the uppermost boundary and 5:00 o'clock as the lowermost boundary. The left two-thirds of the star itself appeared to vary from dark orange to yellow to white in the center. In the space between 2:00 and 3:00 there was a dark red glow; above and below the red glow and extending much further in length were streaks of light, blue-green in color. All the lights seemed to pulse every second but about every ten seconds the red glow would become dominant and encroach upon the blue-green fingers. It maintained the same steady course and acted in all other respects just as satellites that we have observed before, finally disappearing to the southwest.

You have undoubtedly seen publicity concerning various sightings here in the valley during the past month or six weeks. I have no idea what this was that we observed but felt that, knowing me and my family, you would be interested in having this report and would know what to do with it.
