VERY ACTIVE AIRWAY THAT EXTENDS EASTWARD OVER THE SUPERSTITION MOUNTAINS, AND THERE IS NO WAY TO CHECK ON POSSIBLE VFR TRAFFIC. EXCEPT FOR AN ACTUAL UFO, THIS SIGHTING COULD BE ONE EAST BOUND AIRCRAFT THAT WENT OUT OF SIGHT OVER THE CREST OF THE MOUNTAIN AND ONE AIRCRAFT WEST BOUND THAT TURNED TO THE SOUTHEAST. AT NIGHT IT IS EXTREMELY DIFFICULT OR IMPOSSIBLE TO DIFFERENTIATE BETWEEN MOVEMENT AWAY FROM OR TOWARD THE VIEWER DUE TO LACK OF DEPTH PERCEPTION REFERENCES.
