OBJECT THEN BEGAN A DESCENT IN A CURVING PATH UNTIL IT WAS 25 FT OFF THE GROUND. AS THE OBSERVER MOVED TO THE RIGHT, OBJECT DID ALSO, ALTHOUGH IT DIDN'T COME TOWARDS HER. OBSERVER RAN INTO THE HOUSE, LOOKED OUT THE WINDOW BUT THE OBJECT WAS GONE.
