This is in reply to your request for information on your aerial observation of 4 September 1965.

The description, duration, and direction of flight are characteristic of satellites. On 4 September, Echo II was traveling northeast of New York at 7:28 p.m. Eastern Standard Time. If the time of your observation was Eastern Daylight Time, the object you observed was Echo II. If the time was not Eastern Daylight Time, then you probably observed one of the other 30 satellites or satellite components which are visible to the naked eye.

Echo II was traveling northeast at 728pm EST over New York on 4 Sep. If the time given in his letter was actually EDT then he observed the satellite Echo II. If this is not the case then he probably observed one of the other thirty satellites and satellite components in orbit which are visible to the naked eye.
