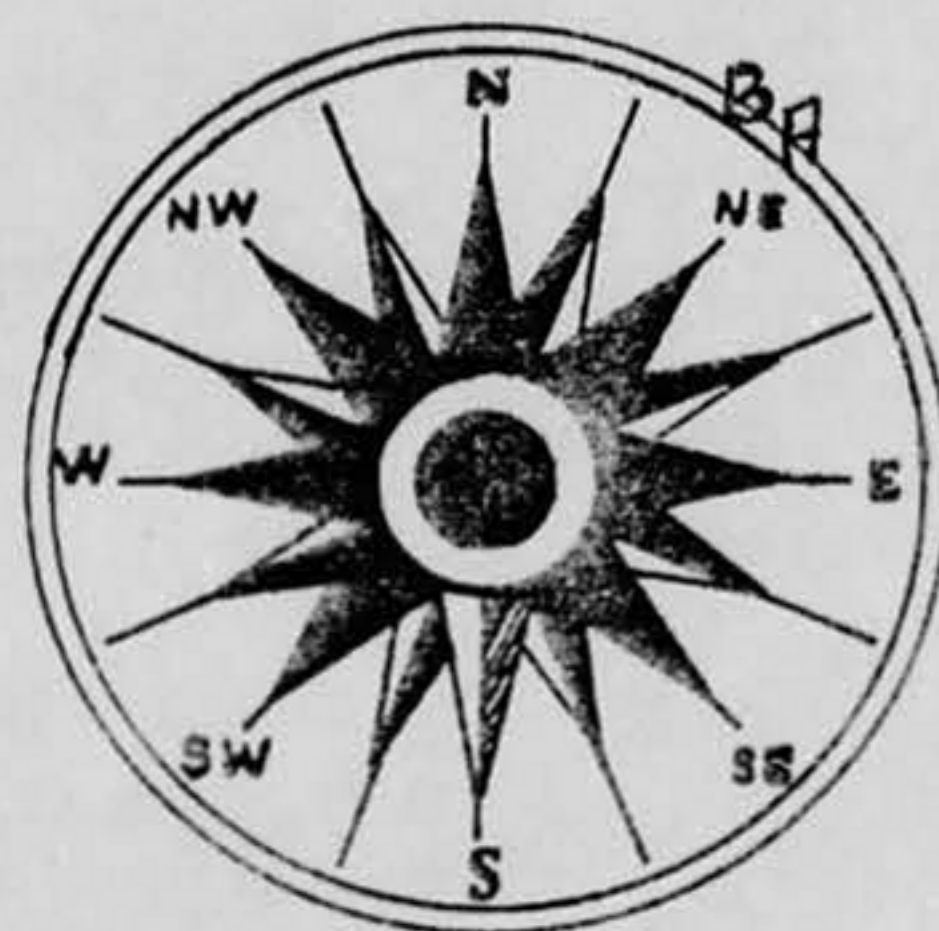
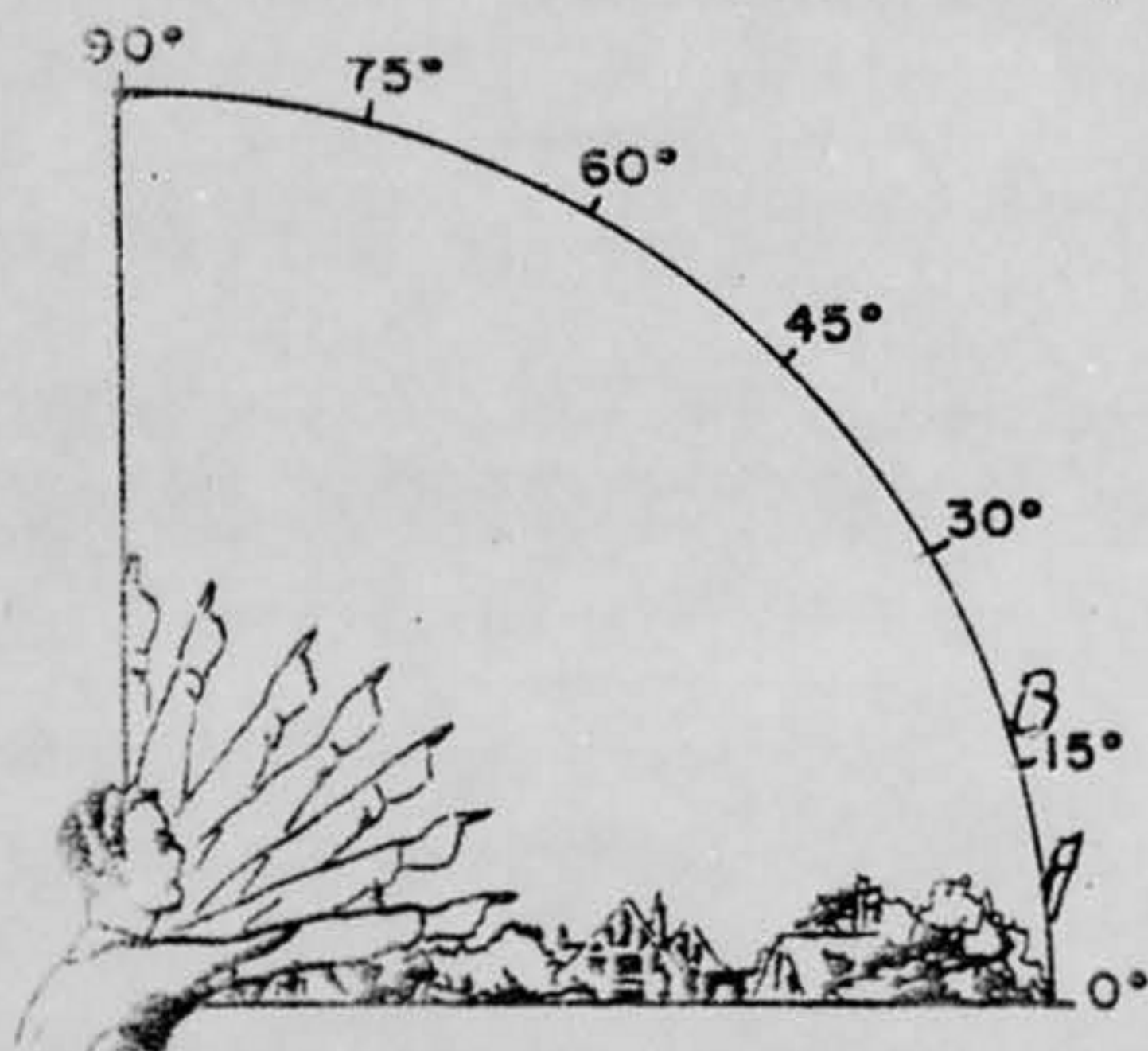

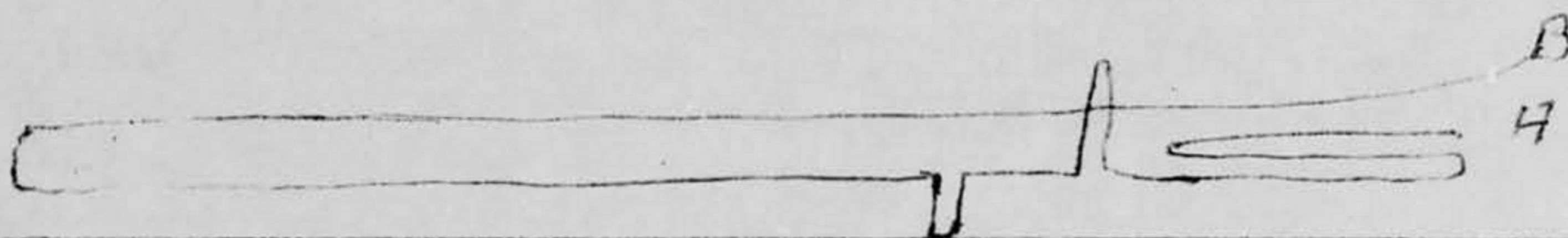

35. Information which you feel pertinent and which is not adequately covered in the specific points of the questionnaire or a narrative explanation of your sighting.

During the 30 minutes that we watched the object its light changed from green to red to white.

Its actions as it retraced its path then go forward from slow to fast, then to a crawl and then speed up and suddenly stop and the right angles it made were amusing to my family. They remarked that to take such risks the pilot had too much to drink. My impression of the object while I watched was that it acted as though it was excited about something.

At 10:30 P.M. my son ~~and~~ and his family started to go home and as they left the driveway the object started to come toward us. My first thought was to call my son while he was driving away but decided not to startle him while his family were in the car. I took my position in the yard.

The object stopped in front of a tall chimney above the railroad tracks opposite our back yard. It was tilted and the windows and brilliant light were the first things ^{we} saw as it revolved. Then it leveled itself and the outlines and columns separating the windows were clear.

and distinct also the dome above and under the object.

The first 2 minutes we admired the object and the exclamations that we made during the 3rd. minute while the object was revolving, seemed to chase it away, because suddenly the object took flight in great speed.

Then ~~we~~ called the radio stations and the second radio station told him that they received another call about the object and directed him to call the airport. Cleveland Hopkins International Airport called us same evening and we were told to write a letter about this experience explaining about what we saw.

I called my son ~~and~~ and told him what we had seen. He told me that as he was driving on W. 65th. toward Lorain Ave. He glanced in the direction of my house and saw a huge brilliant light above my home, I told him it was close but the light he saw was in front of the factory's tall chimney.

P.S. On Oct. 9, 1965, While working on question 18 in this questionnaire, I stepped outside to test the distance and saw a similar object that stayed in the distance, exactly in ^{the} same position as the other object I had seen on Sept. 4, 1965.

It was in view from 10:35 P.M. to 11:25 P.M.

Report of phone call made on January 14 to Mrs. [REDACTED] The witness, one of several, seemed of good reliability. There is a possibility that the object sighted was an advertising plane flying over a local football field where a game was in progress. Also the description of the trajectory made by the witness did not support this. The fact that this was by only one group of witnesses in a metropolitan area in the early evening of the summer night makes the entire case suspect. It is likely, therefore, that an advertising plane was misidentified as a flying saucer.

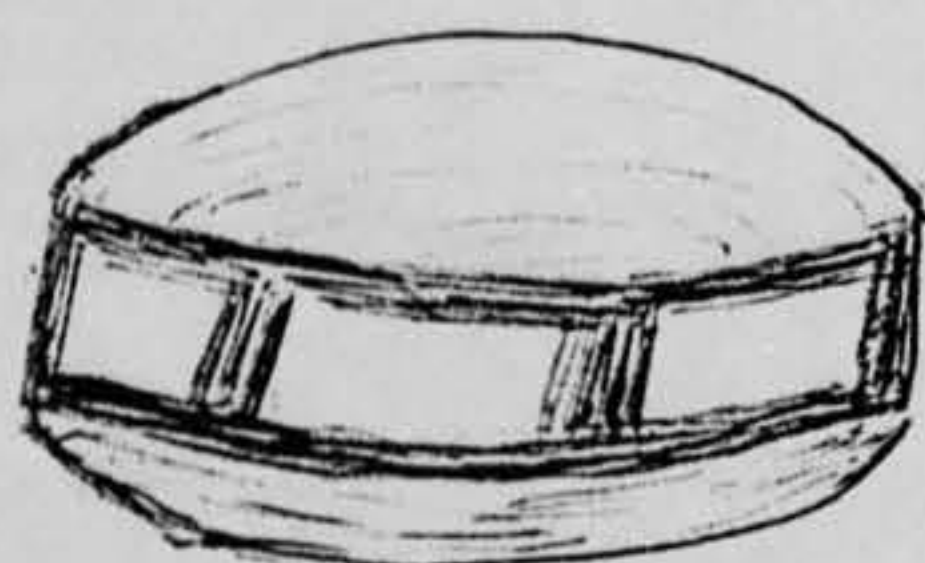
Dear Sirs;

On the evening of Sept. 4, 1965 at 10 o'clock my family and I noticed a white moving object in the sky. We thought it was Telestar, but as it moved a short distance it stopped and retraced its path. Its light changed from green to red and then to white again.

We were guessing ^{then} if it was an airplane or a weather balloon. When a gust of wind blew the object traveled against it several times. The object then traveled forward very slowly and with great speed it retraced backwards its path and stopped. Then it speeded forward and made a right angle up-wards, retraced itself down, traveled a short distance straight then down out of sight then back in view.

After watching for 30 minutes the object traveled swiftly in a straight line toward us, about 200 feet above the railroad track close to a tall chimney of a factory opposite our back yard, it stopped

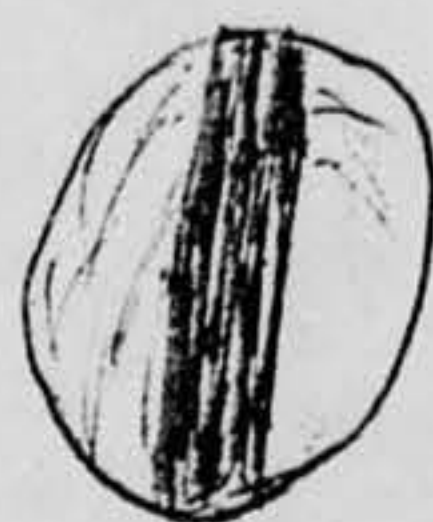

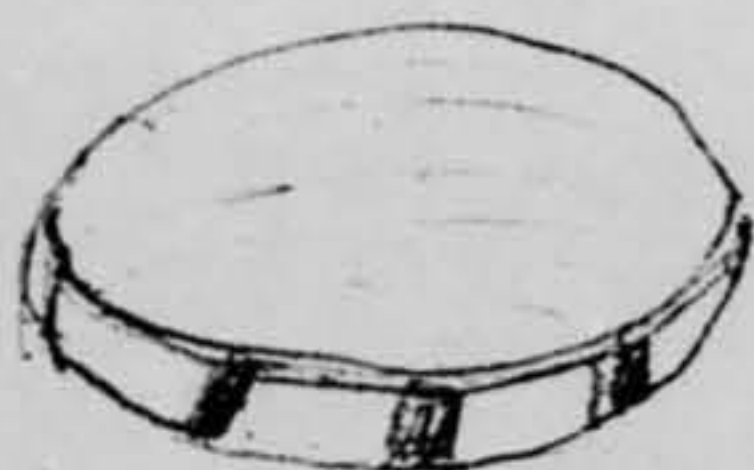

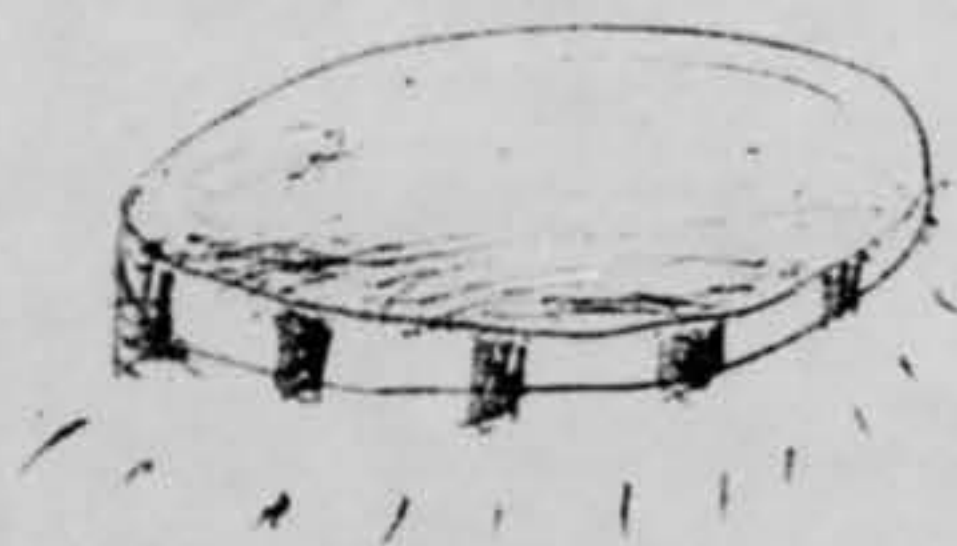

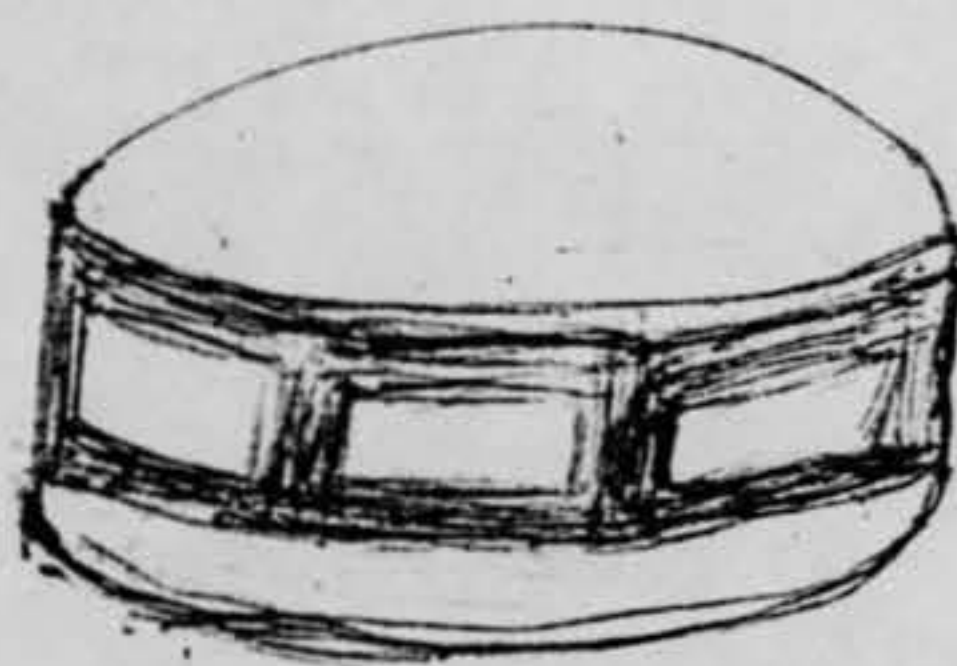
