Seemed to appear and disappear three times. Observer assumed the object was going up because it appeared to be getting smaller. The moon was in the same position as the object and would be visible in the daylight although it would be very dim just as the object was described. Also it would appear to be cigar shaped since it is in its last quarter. As the sun rises higher in the sky the moon would appear to dim to the point where it would no longer be visible.

This was all very clear. No mist, so I saw it disappear the first time.

This is the way it looked the first time I saw it. It was tail-on, how long it was up there, I don't know.

These things on the side were real glazing + cast down on the object. I had a brush to remove it.

1st time I saw it, 4-5 min. it disappeared

2nd time I saw it

3rd time I saw it, it came out of sight, got smaller, disappeared.

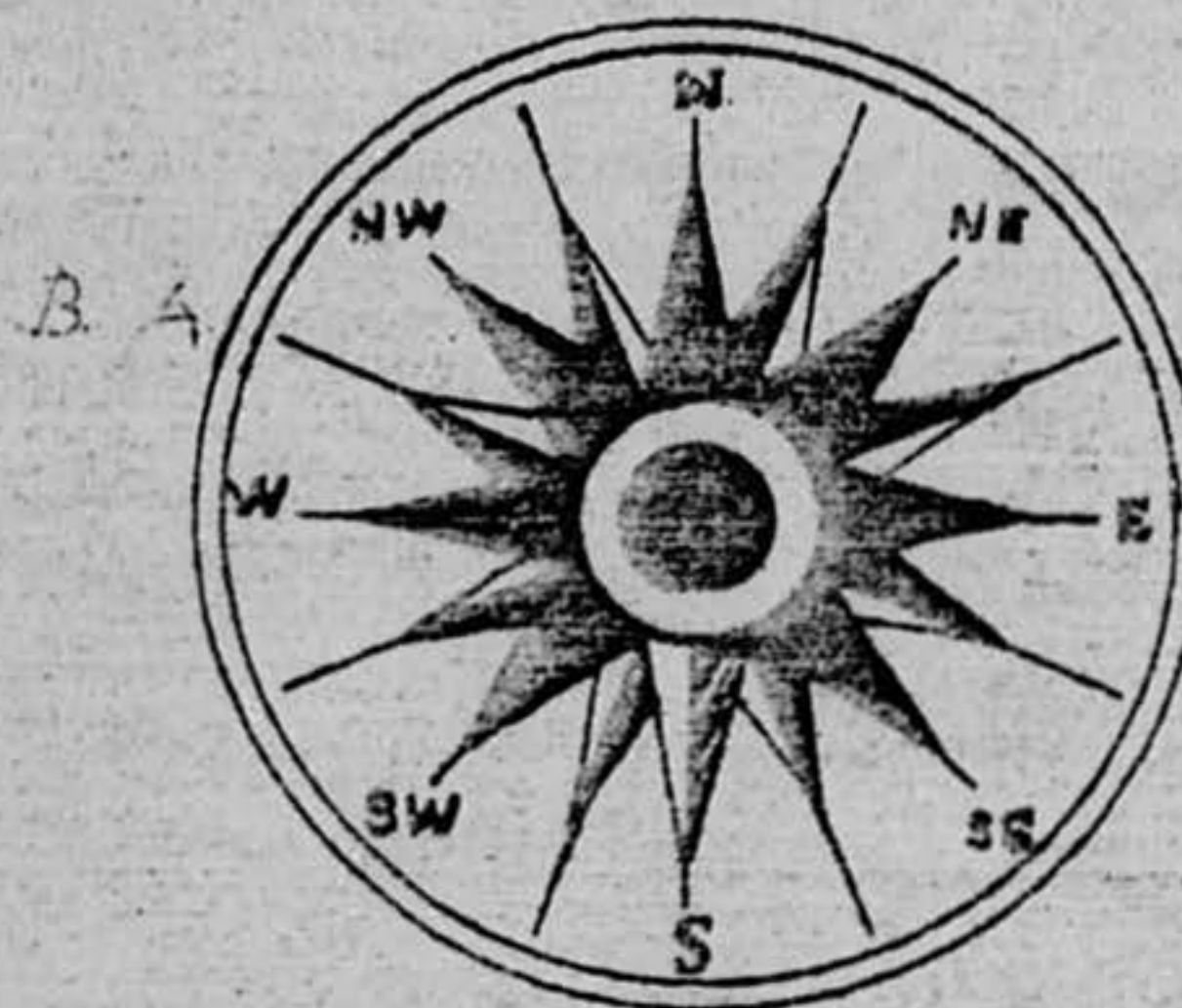
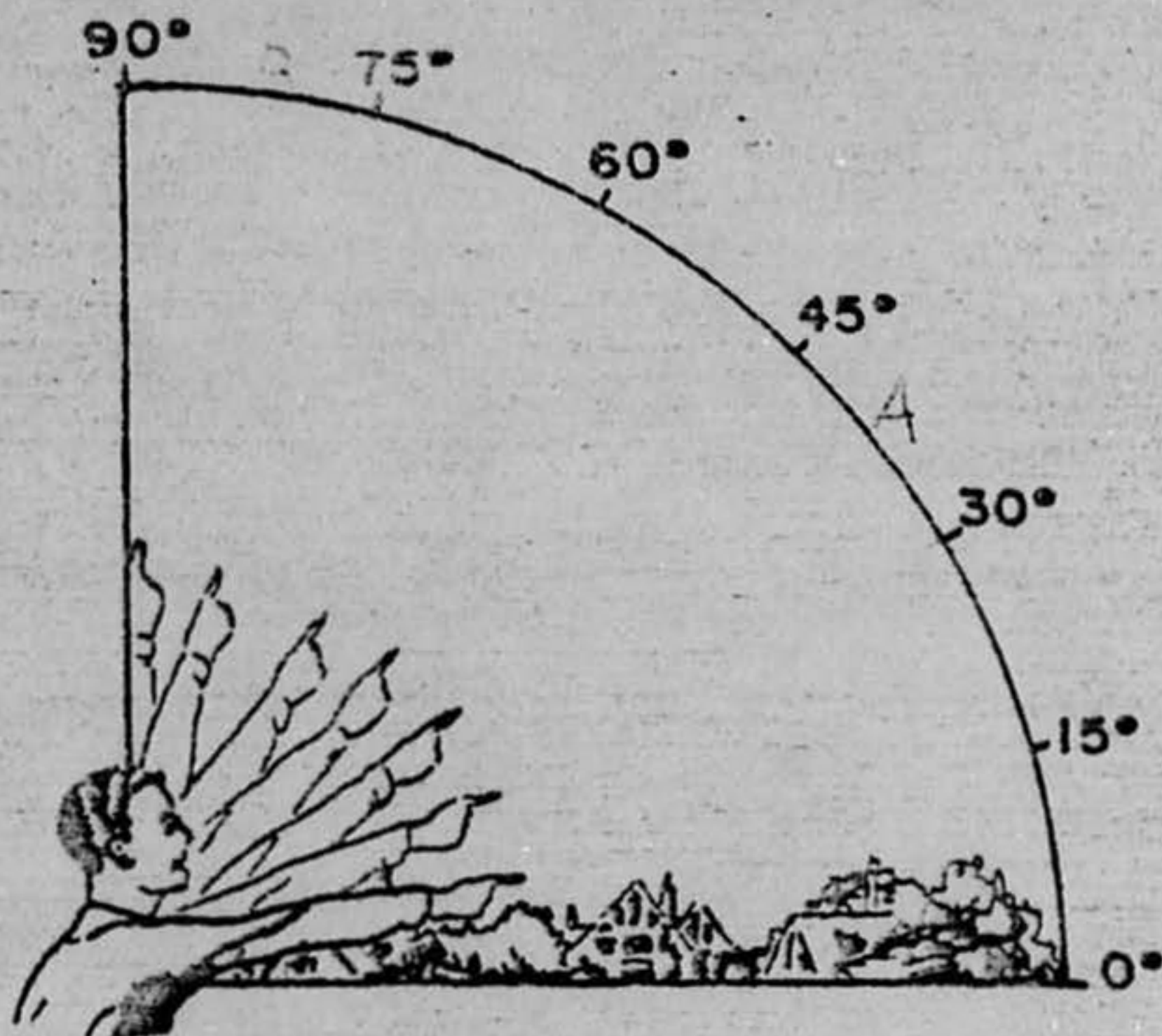

Dear Sir:

Please forgive me for the liberty I am taking in writing you, but this has been on my mind for at least a month, I feel I should tell you of the object I saw in the sky.
