No Saucer Watcher

"I'm not a saucer watcher. I just stumbled on it by chance," said Mrs. Alice Danuszar of Riverside Rd., Sandy Hook, Newtown, last night referring to the strange object she saw on two different occasions within 24 hours.

Mrs. Danuszar said she happened to awake at 4 a.m. yesterday morning. After getting a drink of water she was about to return to bed when she observed a strange lighted object in the west.

"The light was much brighter than a star," she said. In an effort to obtain a better look at what she wasn't sure she was looking at, she got her binoculars and peered at it through them.

She described the object as being shaped somewhat like a TV tube with the base end downward or somewhat like an ice cream cone. A metallic bluish-green flame came from the bottom and at various intervals red antennae appeared to thrust outward from around the top in different numbers at a given moment.

Lights Vary

She said they varied from two to five in various combinations. "Then I got scared," she said. However, she continued to watch the object for about an hour. It did not stay in one spot but appeared to hover then go to one side and another and up and down, changing position from time to time.

"It was five minutes to five before I dared to call anyone," Mrs. Danuszar said. She called her brother Conrad Fleischmann and her neighbors Mr. and Mrs. Phillip Britton.

"At first they thought I was crazy. At first I thought I was seeing things, but I know what I saw," she said.

Mrs. Britton said she and her husband saw the same thing as they looked out the window yes-

terday morning. Both said it was definitely not a helicopter nor did it have any resemblance to an airplane.

Seen Again

Last night Mrs. Britton telephoned Mrs. Danuszar to tell her to look quickly, that a similar object to the one they had observed earlier was in the sky. This was between 5 p. m. and 6 p. m.

Other residents of Sandy Hook have reported seeing strange "saucers" or objects in the sky during the past week.

Mrs. Danuszar said "I can't afford to make a doped fool of myself. I know I'm not nuts

or anything." Others that claim to have seen the strange objects echoed Mrs. Danuszar's sentiments. All said they would like to know what it really is they observed. "Is it earth made or has it come from outer space," they asked?

'Saucer' Watcher Not Convinced

NEWTOWN — Mrs. Alice Danuszar of Riverside Rd., Sandy Hook is far from convinced that what she saw in the heavens earlier this week was a balloon.

"I think I would know a balloon when I see one," she said. She further explained that the object she saw in the sky at 4 a.m. in the morning had the brilliance of a star. She said she first saw it in the eastern part of the sky and it later moved in to the southwest.

It was indicated yesterday that what she saw might be tests by the Robert Fulton Co. in Danbury of a rescue balloon. Night testing began this week.
