Dear Sirs:—

On Friday, around 3 P.M.
on, either, the 22nd or the 29th
of April, (this year) I was
working in my garden when
I heard a "jet", and looked
up. It was coming toward
me from a northerly direction
going south. It was about
400 yds from me, and, I
could see it very plainly as
it came toward me.

Right beside the jet,
on each side, were two very
small (compared to the jet)—
"somethings" that I couldn't

see, but leaving two small,
but very distinct contrails.
The one on the right was al-
ready abreast of the jet when
I first looked up, but the
one on the left was just
coming up - they were very
close to the jet - one might
say "bugging it". When the
left one also came abreast of
the plane, they both left it
very abruptly, made a large
arc to the left - about 300
yds - and spiraled up -
and I'm assuming - out
of sight, since at the top of
the arc or spiral the contrails
"shut off" abruptly. They ^{curved}
side by side, like twins.
I was ^{about} going to mention
this, but it occurred to me
