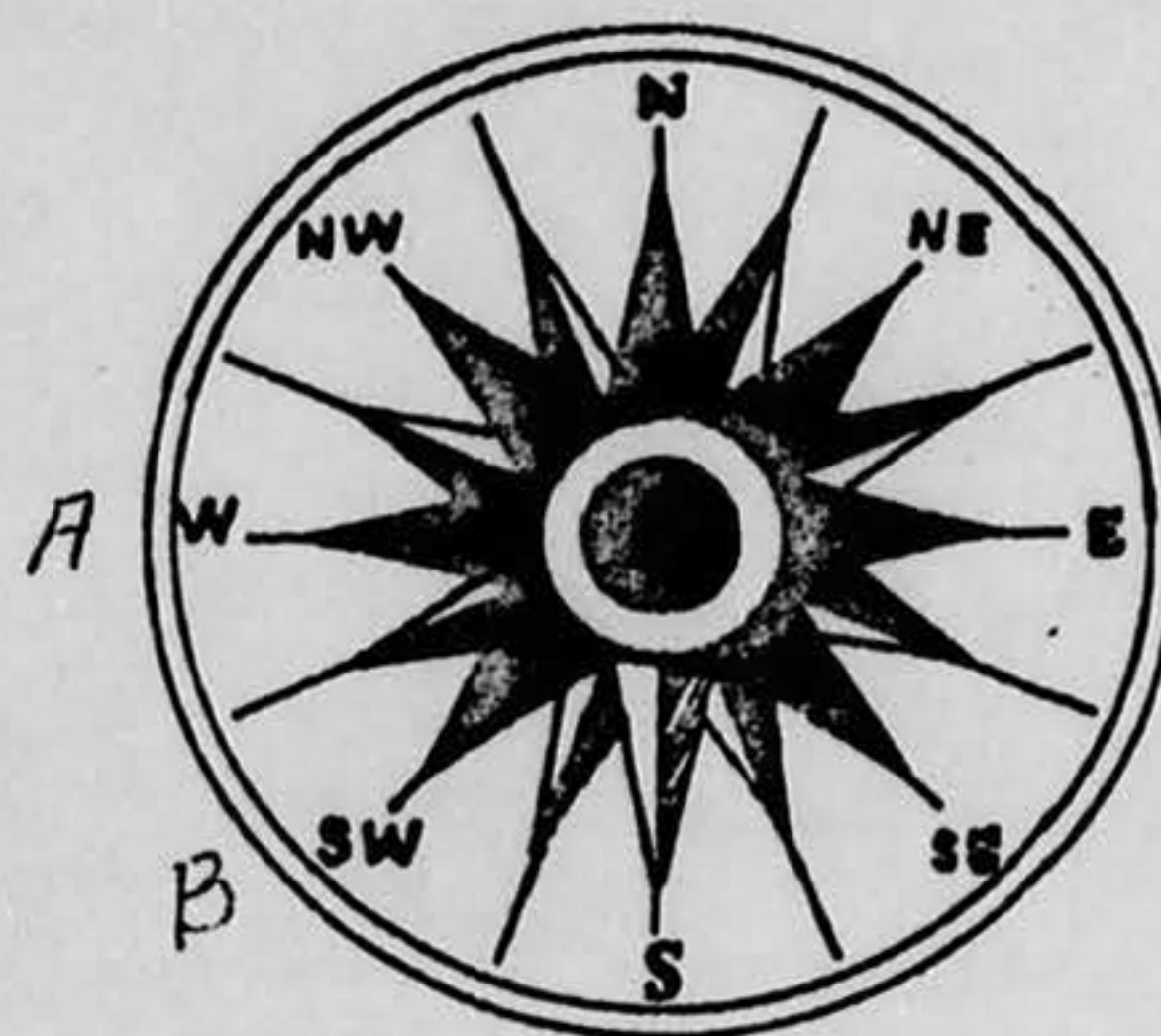

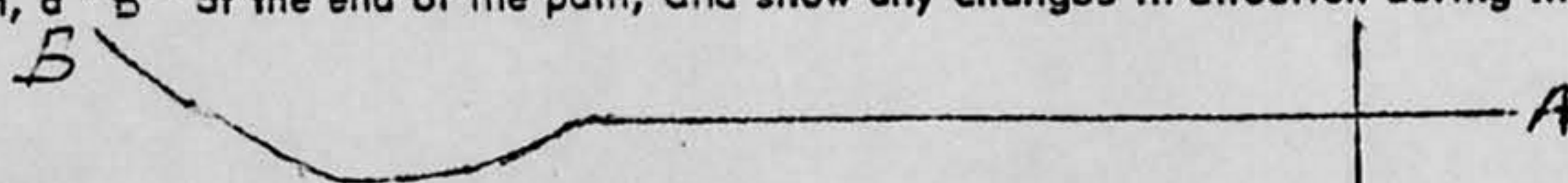

35. Information which you feel pertinent and which is not adequately covered in the specific points of the questionnaire or a narrative explanation of your sighting.

I live on the second floor of the house and my back porch faces the west towards Midway Air port. I am decorating so I had the shades and curtains removed which had given me the clear view.

I had gotten up at 12:00 O'clock midnight Sunday unable to sleep so I had some coffee and decided to do some more work on my porch. It was almost 4:30 A.M. when I decided to lay down for a while, and all the time I had a small portable radio playing.

I have a small Chihuahua dog which usually cuddles up with me when I lay down. When all of a sudden I heard this sound of the Air raid Defense Siren sound, a continuous wailing sound with no stopping. This had made me wake up my husband and he also heard the sound. The sound lasted almost 13 minutes. I put the radio back on but there was nothing about any special warnings. So my husband went back to bed. I didn't, but I went back on my porch to listen if the sound would start up again. And as I was standing there looking out my window that's when I saw this object out there. at first I thought it was a reflection, it just seemed to be standing still. As I kept watching it, it started to move South straight across the sky I called my husband again to come see a flying saucer. when he saw it, he went to wake up the boys. so they got up and saw it also. My younger boy watched it

with me all the way untill we couldn't see it any more. It took that little dip and then headed South west. So my Son and I continued to stay up because he was curious to see if there might be any more out there but we didn't see anything else or heard anything else after that.

I forgot to mention that when this Siren sound went off, which was quite dark and early yet. It seemed that every bird in the neighborhood was chirping & keeping at the same time. Because I had mentioned this to my husband. There was one sound in particular that sounded like something whirling around and screeching. These sounds were quite clear because I had several windows open at this time.

After every body left for work and school I called up Midway Airport about what we had seen and asked if they had set off the air raid siren because of the flying unidentified object and they said that they don't know any thing about it. So I called many places untill I called

O'Hare Air Force Base - 694.3031 and some head man there had taken down all the information.

This incident is as clear in my mind now as it was that early Monday morning, and I shall remember this the rest of my life.

I heard so much about these flying things and I always told my kids I'll never believe it till I see it. So now I did see it. I only wished that it could have been closer or lower so we could have gotten more details about it.

We had just bought a very expensive camera which would have taken a picture of it. But as you know how it is there wasn't any film left. This camera we are told will take pictures out doors in total darkness. The name of it is Iraid.
