Mr. [redacted], above address, reported to Police Headquarters, McClellan AFB, 2030 hours, 29 Apr 66, that he had sighted 2 UFOs at 1130 hrs, 28 Apr 66, while walking home in the vicinity of Madison Avenue in Sacramento, California. The objects were seen at an angle 30 degrees from ground level. They were lit up and coming toward him, but veered off in the direction of Folsom, California. The objects went back and forth, sometimes stopping. They seemed to be traveling at approximately 50 mph. One of the objects stopped and there was a bright light, like landing lights, turned on for a few seconds. The objects appeared to be in the vicinity of Sunrise Avenue and Winding Way in Carmichael, California.

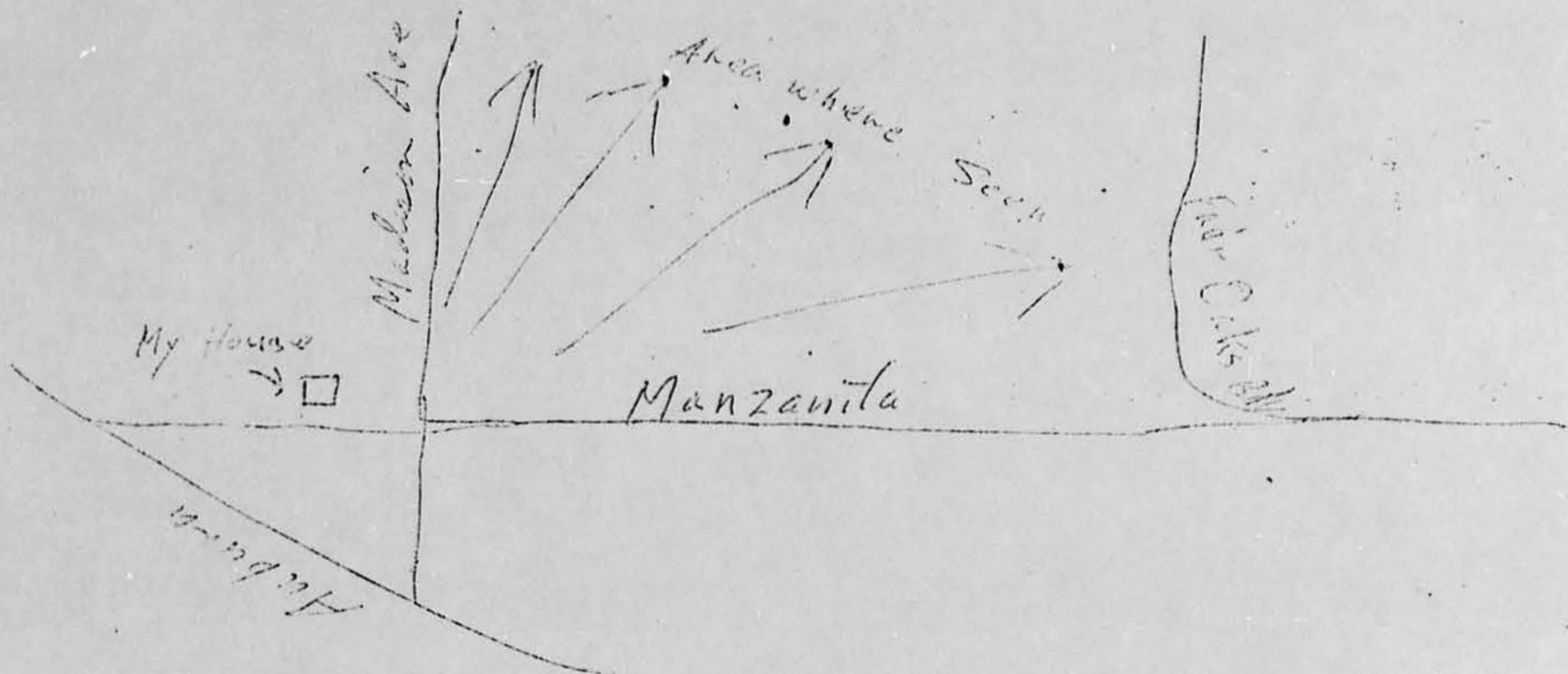

I sighted an object all the way up in the air on an angle of 30 degrees from an approx. position of Fair Oaks & 1st Cambridge Sts. coming my way. About halfway to me it ~~seemed~~ veered off going in the direction of Folsom City. Another one came in the night. I shot two of them. They just went back and forth over the city. They seemed to be traveling at approx. 30 mph. One stopped and I shot it. It fell right there landing right in the middle of the road.
