As I wrote this letter to you the local news station WBSN is reporting one [redacted] New Bedford Mass. telephone number [redacted] as seeing a so-called "Mother" ship 100 feet in diameter. 4 AM in Westport Mass on Route 88. The UFO followed his car, and then landed in front of his car. He stated to the State Police that he watched it for over 15 minutes. The UFO colors were White-Yellow-Blue and Green in that order as it flew away from him.
