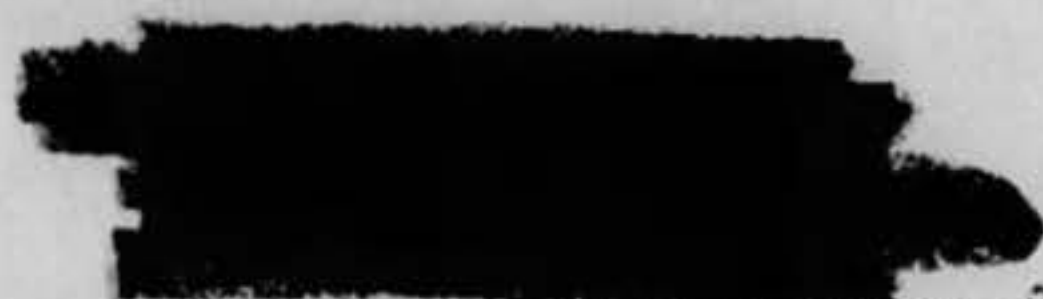

One of the lights was visible for about 30 minutes after having reappeared after its initial disappearance. The first light moved up and down very quickly for short distances. When the second light appeared it moved right down, left up before its disappearance. Observer stated that as he traveled the objects were still in the relatively same area as when he first saw them. |

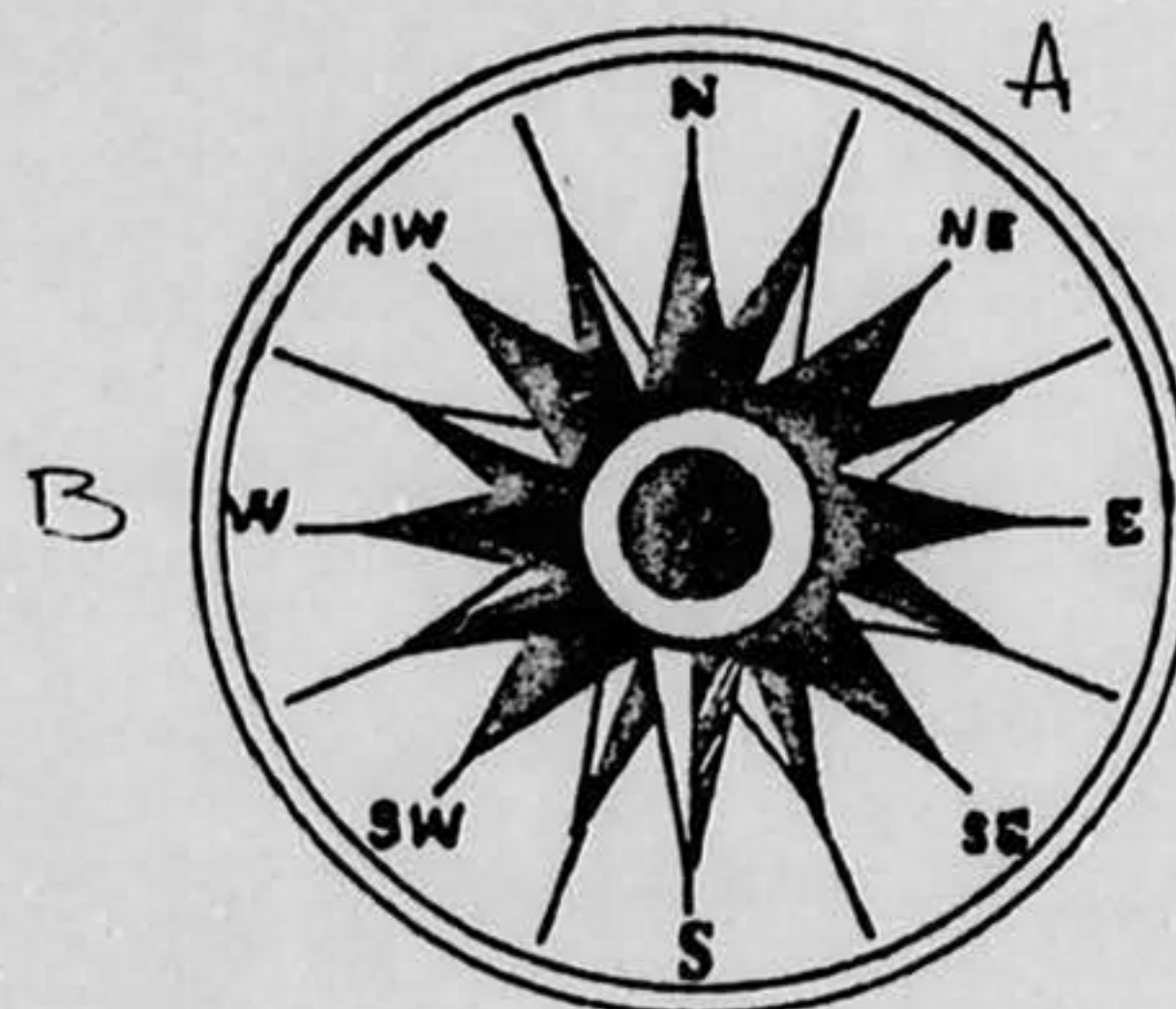
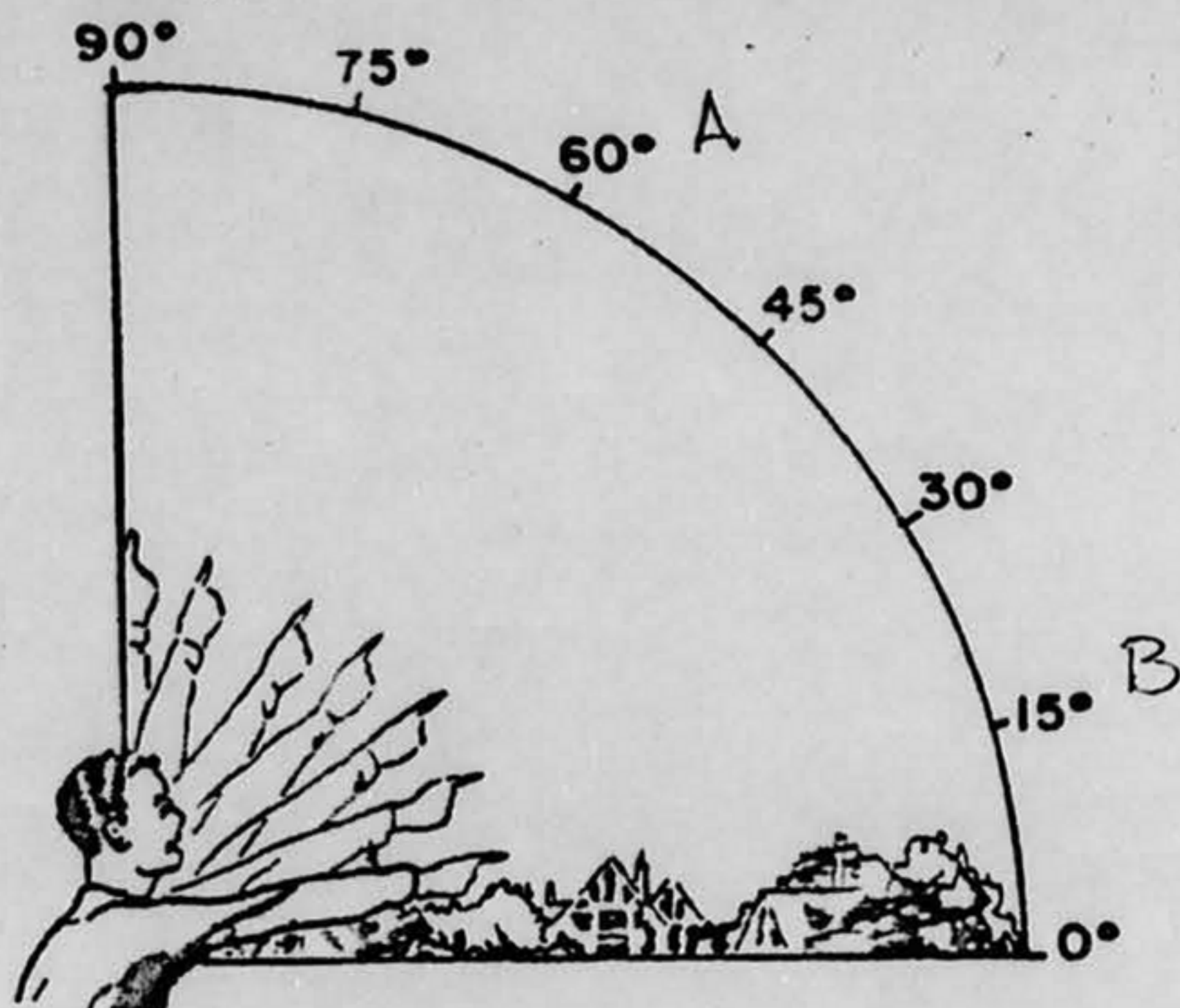

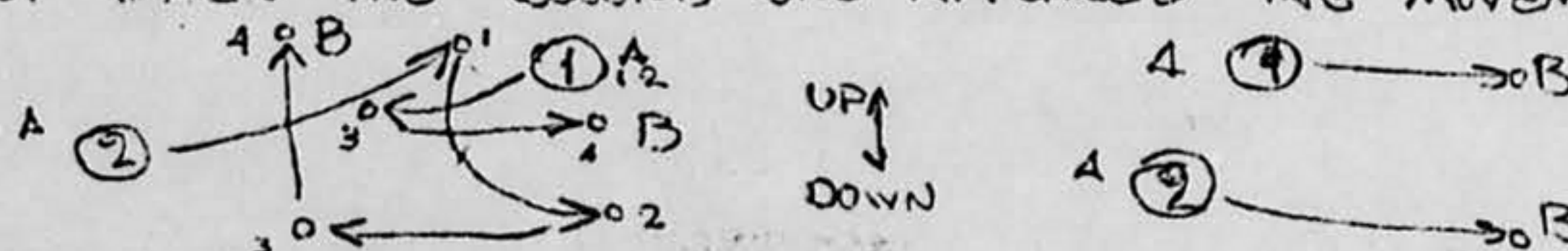

THE OBJECTS (LIGHTS) WERE NOT OF AN AIRPLANE OR HELICOPTER AND WERE NOT CONNECTED TO THE GROUND. I TRIED TO COMPARE THEM TO OBJECT IN THE AREA. I SAW A COUPLE OF AIRPLANES TO THE WEST BUT THE "LIGHTS" WERE TOO BRIGHT TO BE AN AIRPLANE AND THE CORRECT RUNNING LIGHTS DID NOT EXIST. THE "LIGHTS" WERE TOO FAR ABOVE THE GROUND TO BE WARNING LIGHTS ON A GROUND OBJECT. AS I TRAVELED I WATCHED THEM WHILE I TRAVELED OVER 30 MILES AND THEY WERE STILL IN THE RELATIVELY THE SAME AREA AS WHEN I FIRST SAW THEM. I WATCHED THE ONE LIGHT FOR OVER 30 MINUTES WHILE THE SECOND ONE I SAW ONLY THE LAST 5 MINUTES OR LESS. IT APPEARED AND I SAW ITS MOVEMENT WHILE I WAS STOPPED AND MY WINDOW ROLLED DOWN.

Dear Sirs,

While traveling west on interstate 70 on Friday, May 20, 1966 at about 10:30 P.M.

I saw two unusual lights over Richmond, Indiana. I observed one of the lights for over twenty five minutes. The lights were not those of an airplane or anything connected with the ground, such as a tower. It was a clear red light which was much brighter than an airplane's light, and part of it blinked on and off.

These are a few of the facts about the lights which I saw. I am interested in knowing what they were and if anyone else reported them.
