1. Reference your message 520DC 00158 JUN 66, subject, UFO Report. Your report on the 3 June 1966 sighting by [REDACTED] was lacking certain information that is necessary for an evaluation. AFR 200-2, paragraph 14 states the format that is required for all reports.
2. UFO reports from Suffolk County AFB, in the past, have been lacking certain essential data. Request that future reports include all the information that AFR 200-2 outlines. Radar contact, check of aircraft in the area and a report from the local weather bureau is essential. Also, angle or elevation and azimuth of sighting is necessary.
3. The preparing officer who receives the report initially is in a much better position to conduct an "on-the-spot" survey or followup than subsequent investigative personnel and analysts, who may be far removed from the area, and who may arrive too late to obtain vital data or the missing information for firm conclusions. See the attached AFR 200-2, 20 Jul 62, with change 30 Mar 64, and message from CSAF, cite AFRSTA 987/66 April 1966.
