1. The following is the information concerning a report of an unidentified flying object on the night of 8 July 1966.

2. Description of the object:

- a. Shape - It looked like a missile, cigar shaped.
- b. Size - It looked like a straight pin as far as length and was about as big around as the head of a pin.
- c. Color - It was the color of red-white flame.
- d. Number - There was one.
- e. Formation - None.
- f. Details - This object was flying with its long axis parallel to the ground.
- g. Tail - The object had an incandescent exhaust about five times the length of the object itself.
- h. Sound - None.

3. Description of the course of the object:

- a. The observer happened to look at the sky and saw this object.
- b. The altitude was described as about that of a B-52, about 30,000 ft.
- c. The altitude when the object disappeared was the same as when first seen.
- d. The object followed a course from SW to NE. The observer described the course in terms of, "from White Sands to Chicago."
- e. The object disappeared in the NE due to distance.

- f. The object was visible for about a minute.
4. Manner of observation:
- This was a visual ground sighting.
 - There were no optical aids involved.
5. Time and date of sighting:
- 09/0358Z July 1966.
 - Night
 - Hillcrest Park, Clovis, New Mexico. 34 25N 103 11 W.
5. Douglas P. Millard, A2C, 27th FMS, Aircraft Mechanic, reliable observer.
6. Weather:
- The observer described the weather as thunder storms in the distance but clear star filled sky in the immediate area of sighting.
