No exhaust trails or vapor trails or wings etc. objects looked like spectrum or bright stars and from dimmer as they disappeared from right.

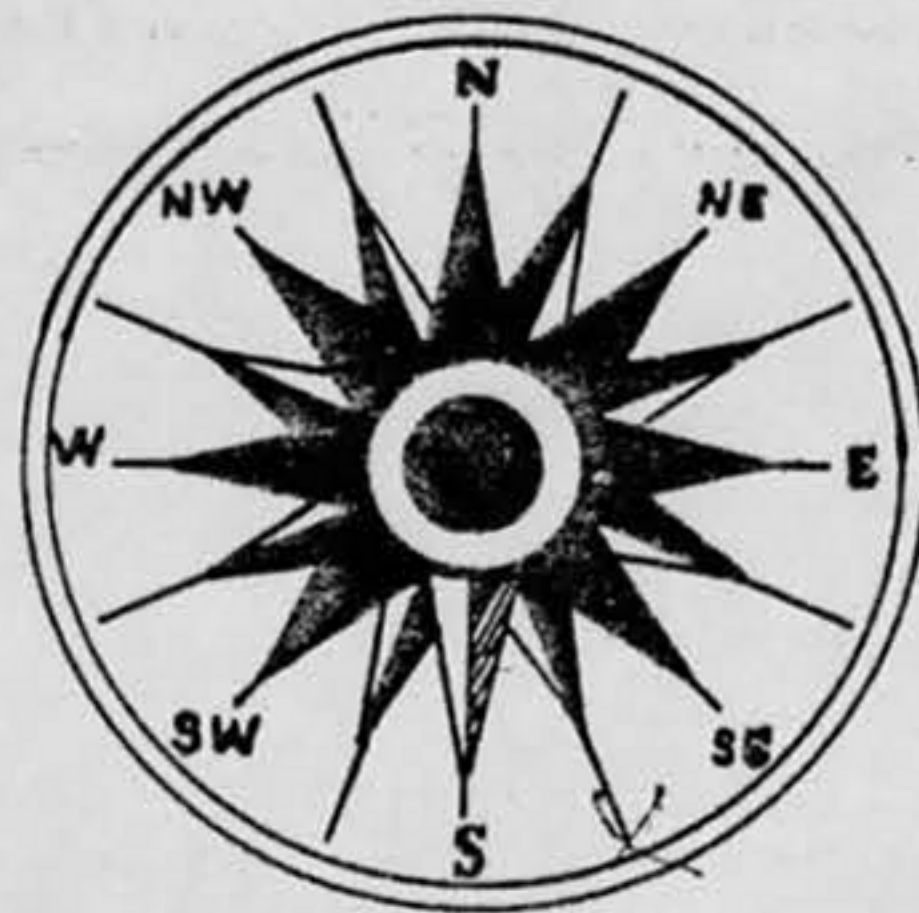
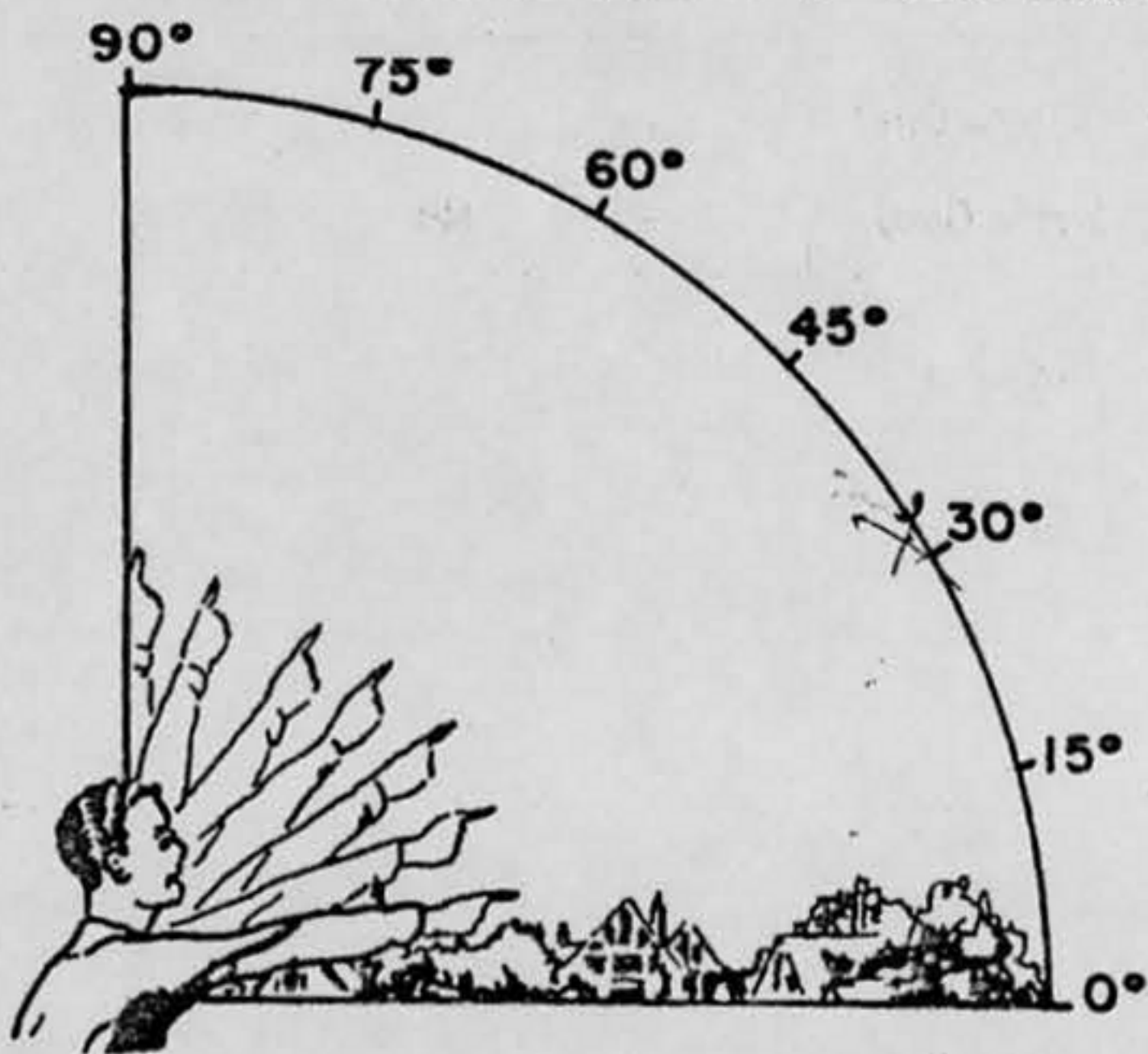

Nobody ever tells me of the findings I did see right or wrong at what objects actually were but the one seen in 40 & about 52 were real I was several hundred ft from the first I thought they were men working rather just finished working on the Power line and it was getting dark but what was funny next time I came this object was not there I thought it a small building by the transformer This was at Wolf Creek near St Clair also I was told there never was mechanically in vicinity & I also relayed perhaps my eye played tricks on me as the men only seemed about 5 ft tall no small no lights they seemed to be searching ground like looking for some thing.

Object in 52 was about 1/2 mile away our car was broke down & I couldn't go investigate but I checked with Penna Power & Light Co St Clair Coal Co & one or two Coal operators & nobody had any equipment in the area or said that I saw the large object send out signals like signals from a ship but flashes were like flashes from electric welding This object was next to a Power line
