I feel my answers to this questionnaire are not too clear so I'll try to explain here. I was sitting on the steps when I looked up and saw a very bright star sparkling what seemed to be silver and a very faint red. I started talking to my friends and when I looked up again I saw a moving object or what seemed to be a star moving across the sky and I informed all who were around me of my sighting and asked them to watch because I had seen this phenomena many times before and no one believed me. They all believed once they saw it themselves and agreed it was not an airplane or anything they had ever experienced seeing before. The moving object crossed over our street from one end to the other in a north east direction until it went over the roof tops and out of our vision. I still do not know if it was the sparkling silver and red star I saw in the beginning that started and moved because I looked down from the sky about 10 minutes before I looked up again and saw the moving object. I looked again for the sparkling star after the moving object went out of sight, but the stars by that time were in a different position and I never could locate the sparkling star or object I had first seen again.

I was and the 3rd floor of my apartment when my husband and his friends called for me to come out on the flat to see the stars moving in formation.
