I was looking directly overhead at the stars in the zenith of the sky when the exhaust trail flashed into my field of vision. I locked onto it and followed it until it disappeared beyond the range of my vision in the southwestern sky.

When it was directly overhead, there were stars visible far above it.

I did not observe any body mass in front of the exhaust trail.

Since observing this, I have wondered if this could have been a meteorite.

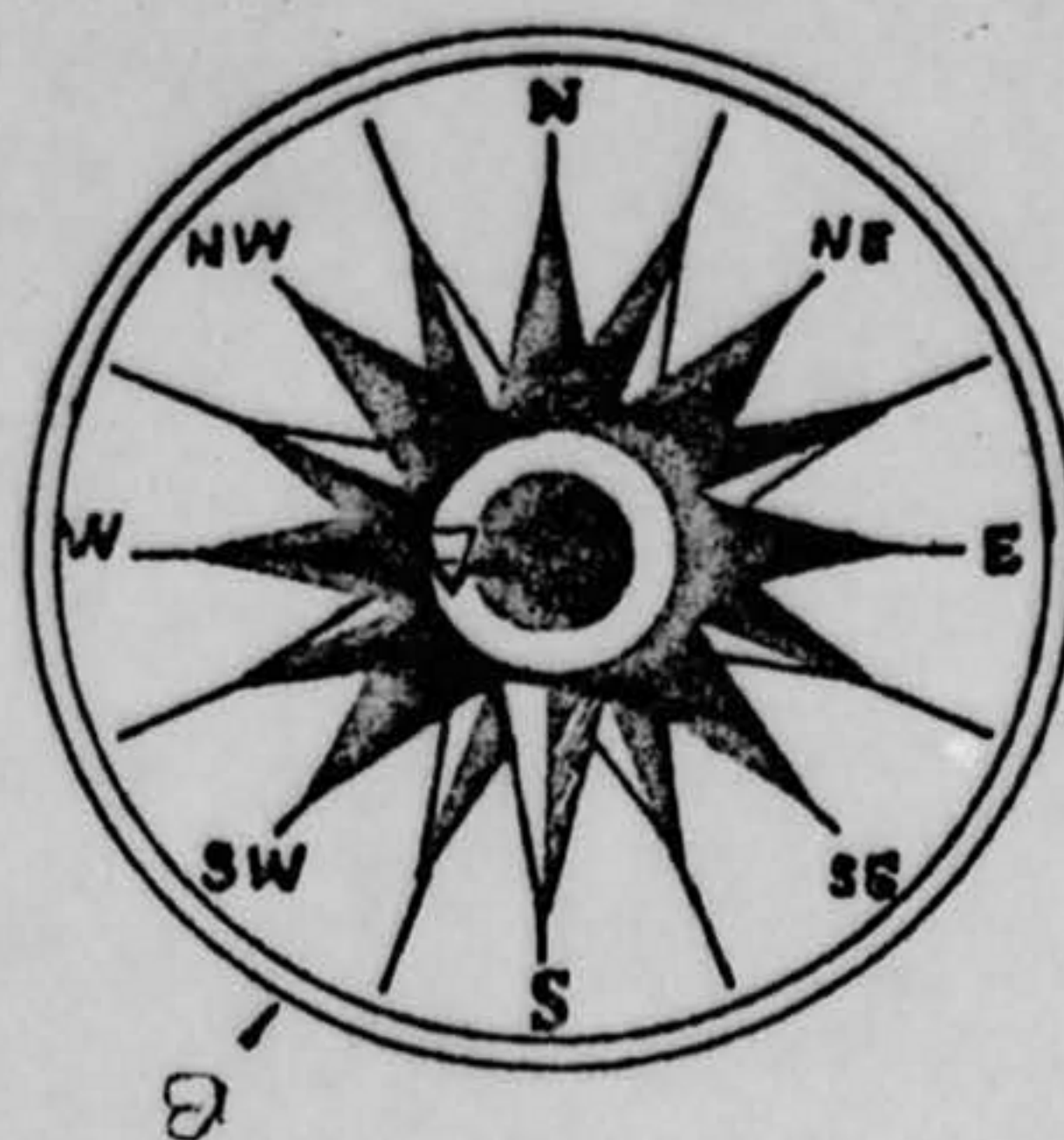
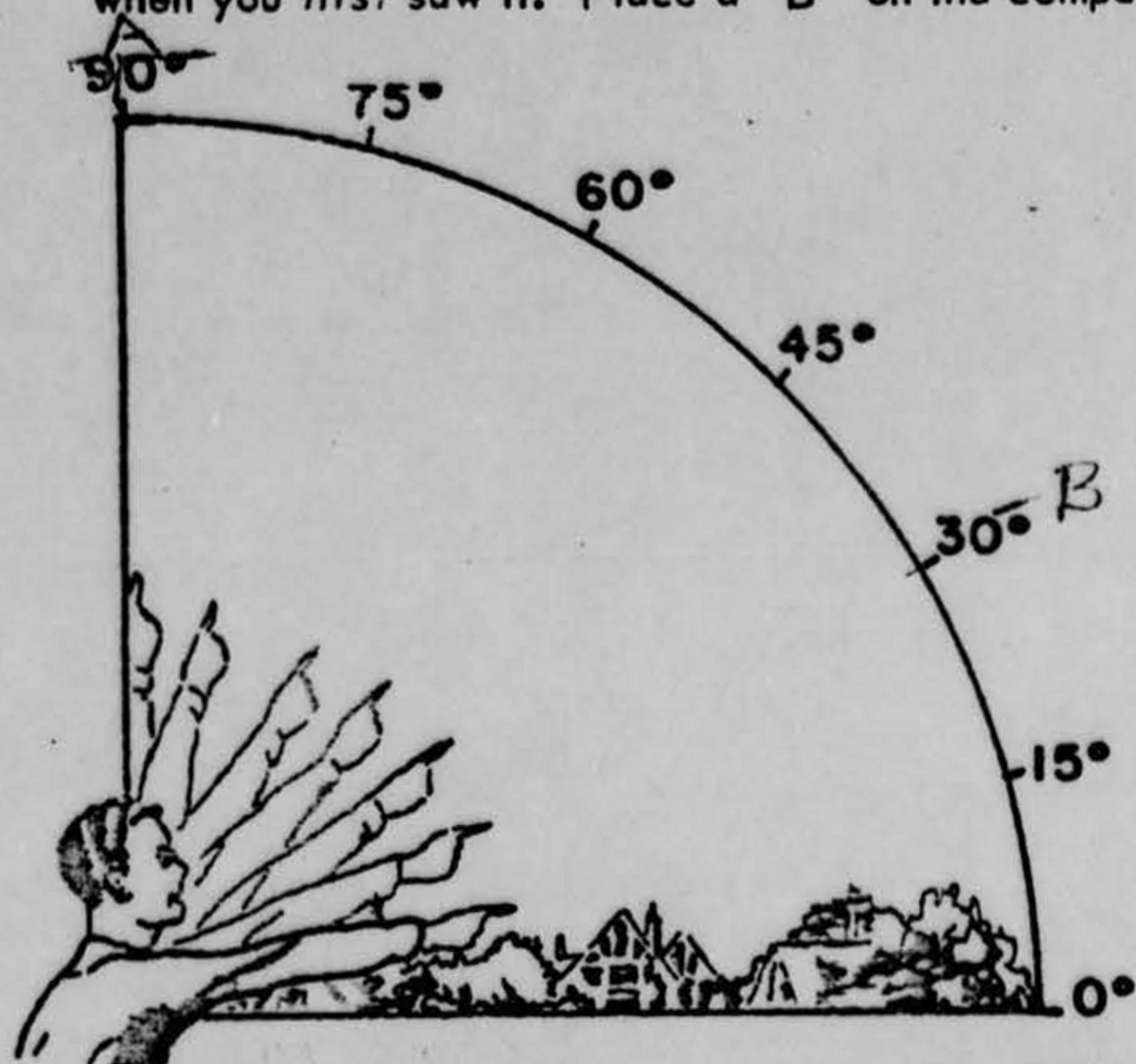

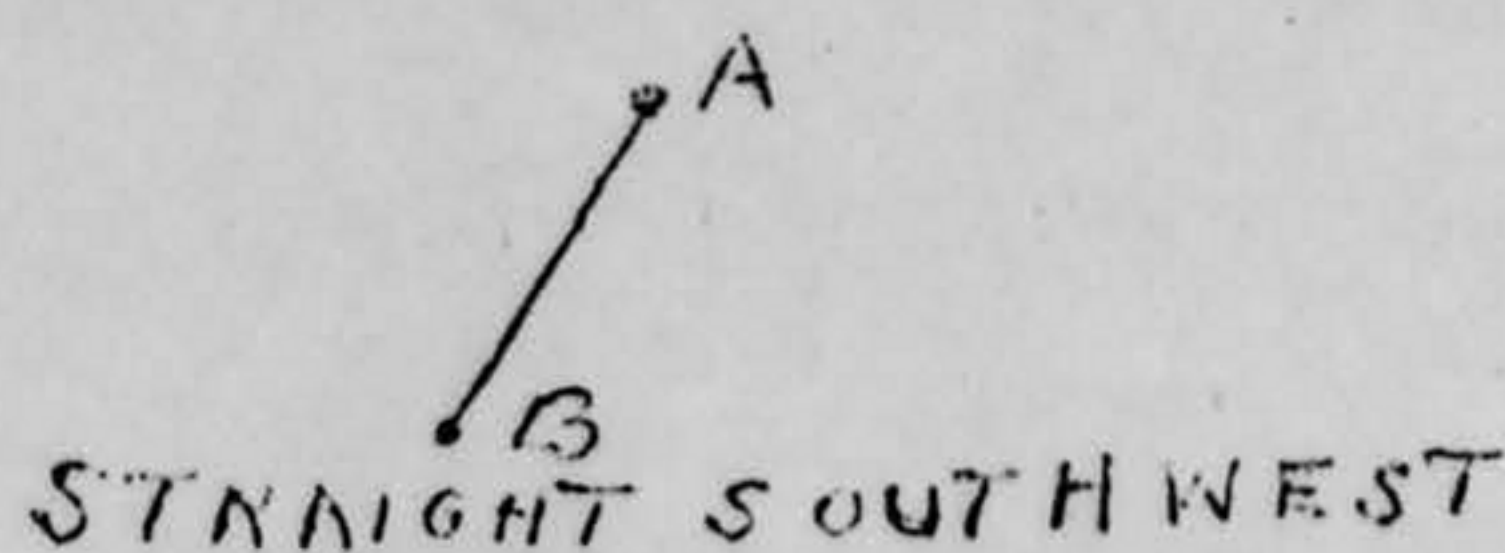
