As I write this letter I write for my brother, my neighbor and myself. The following phenomena as I assure you nothing but plain bare facts. We are of sound mind and have come to the conclusion that all three of us were not seeing things.

On the night of September first, 1966 at approximately nine o'clock central standard time the three of us witnessed a very strange phenomena.

The course when we first sighted it was, as

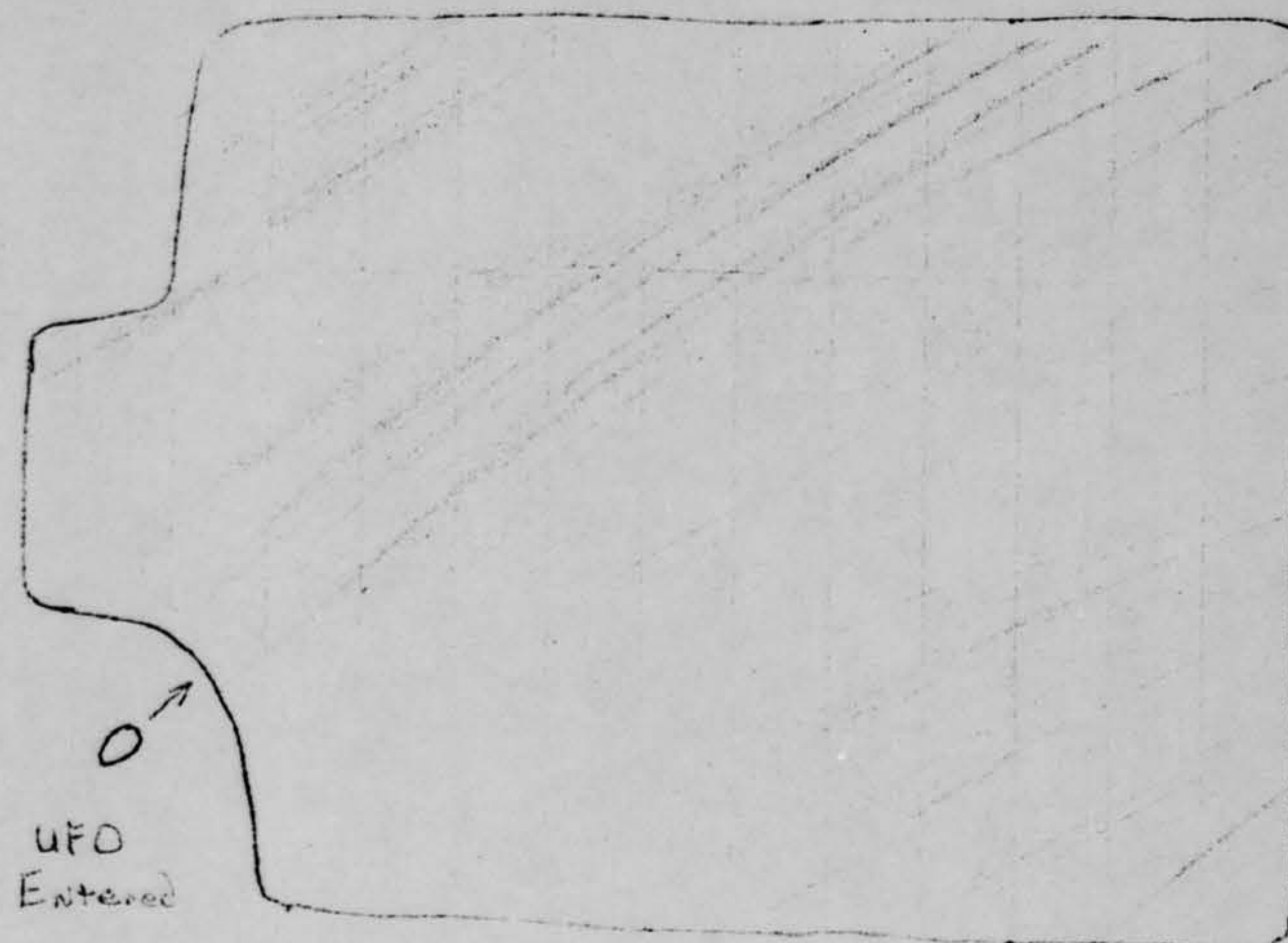
close as we can calculate West by west north for approxi-
