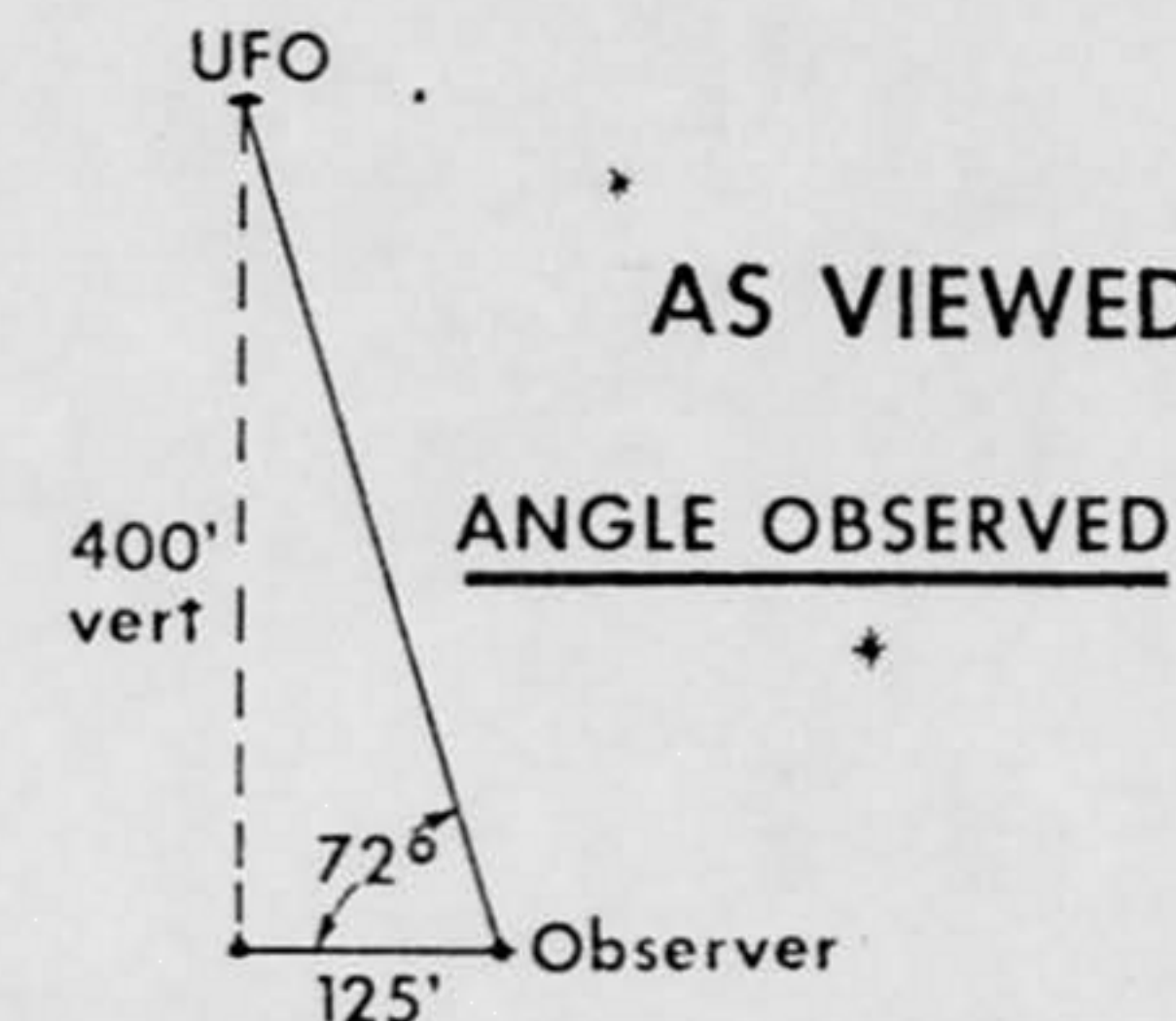

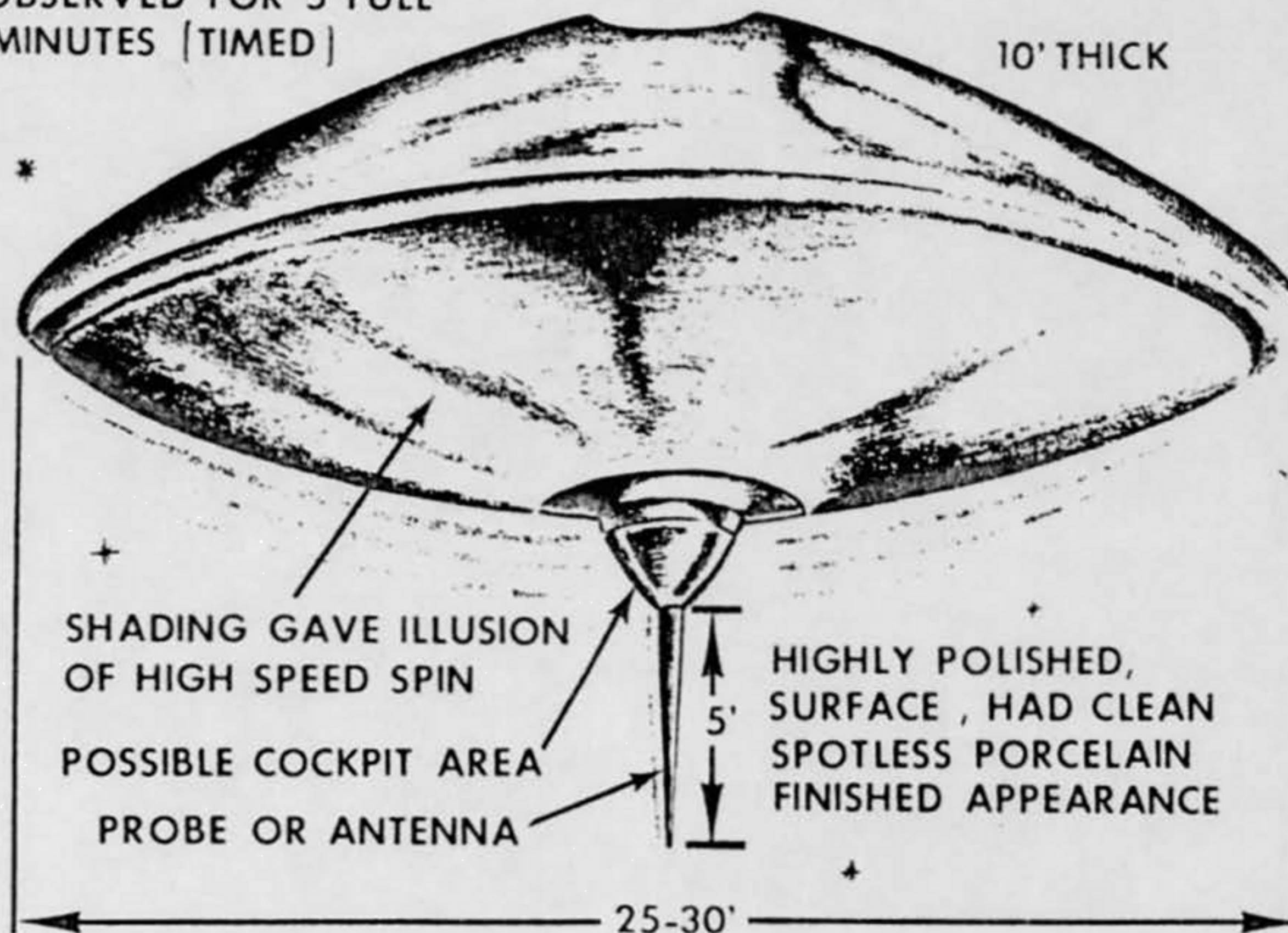

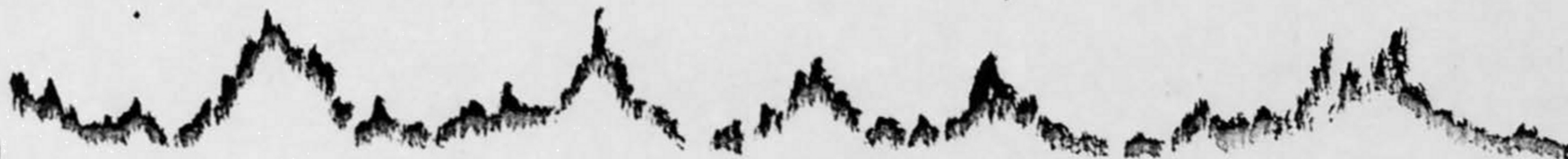


OBSERVED FOR 5 FULL MINUTES [TIMED]

1. UFO APPEARED INTO VIEW FROM THE NW.
2. UFO HOVERED AT 125 FT. HORIZ. AND EST. 400' VERT.
3. UFO MOVED IN STRAIGHT LINE MANEUVERS ONLY, WITH VERY RAPID INCREASES AND DECREASES IN SPEED.
4. NO OBSERVABLE WINDOWS, DOORS, HATCHES OR OTHER OPENINGS.
5. NO HEAT OR OTHER SENSATION NOTED DURING THE PRESENCE OF THE UFO.
6. UFO COULD BE HEARD BY A FAINT HUMMING NOISE APX. 10 SEC.
