VERTICAL TEMPERATURE GRADIENT: 6,000FT PLUS 13, 10,000FT PLUS 12, 16,000FT PLUS 11, 20,000FT PLUS 10, 30,000FT PLUS 9, 50,000FT PLUS 4. COMMENTS OF REPORTING OFFICER: A PERSONAL INTERVIEW WITH MISS [REDACTED] AT THE POINT SHE OBSERVED THE OBJECT LET TO A LOGICAL EXPLANATION FOR HER SIGHTING. SKY HARBOR MUNICIPAL IS LOCATED APPROXIMATELY FOUR (4) MILES NORTHWEST OF GUADALUPE. AN AIRPLANE FLYING AN EXTENDED LANDING PATTERN WOULD PRESENT THE SAME PATH WHICH SHE DESCRIBED. IT IS LIKELY THAT SHE SAW SUCH AN AIRPLANE IN HIS APPROACH TO SKY HARBOR. SHE DOES NOT HAVE ANY PROFESSIONAL BACKGROUND IN THIS TYPE OF OBSERVATION AND SEEMED TO BE A RELATIVELY UNRELIABLE WITNESS. HER 17 YEAR-OLD BROTHER WAS ALSO INTERVIEWED. AS A WITNESS, HE APPEARED PARTICULARLY UNRELIABLE.
