Object stayed in one place, essentially, buty moved up and down and back down to the original spot, repeating this cycle throughout the observation.
7. COURSE Stationary	The description is consistent with that of an astronomical observation. The Big Dipper was not in the SE at the time of the sighting, but the constellation Orion, which does resemble a dipper when taking into account the three belt stars as the bottom of the dipper.

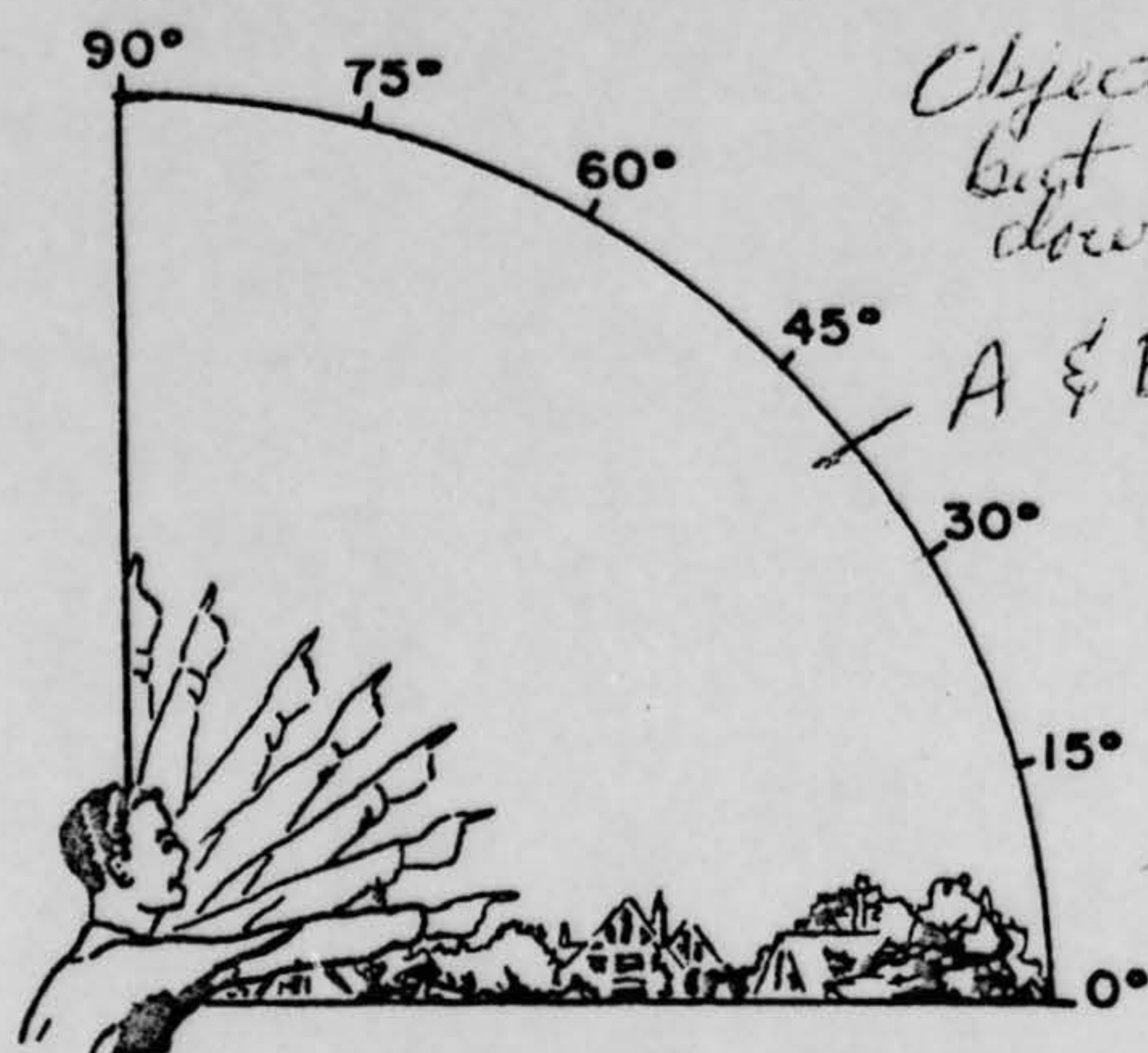

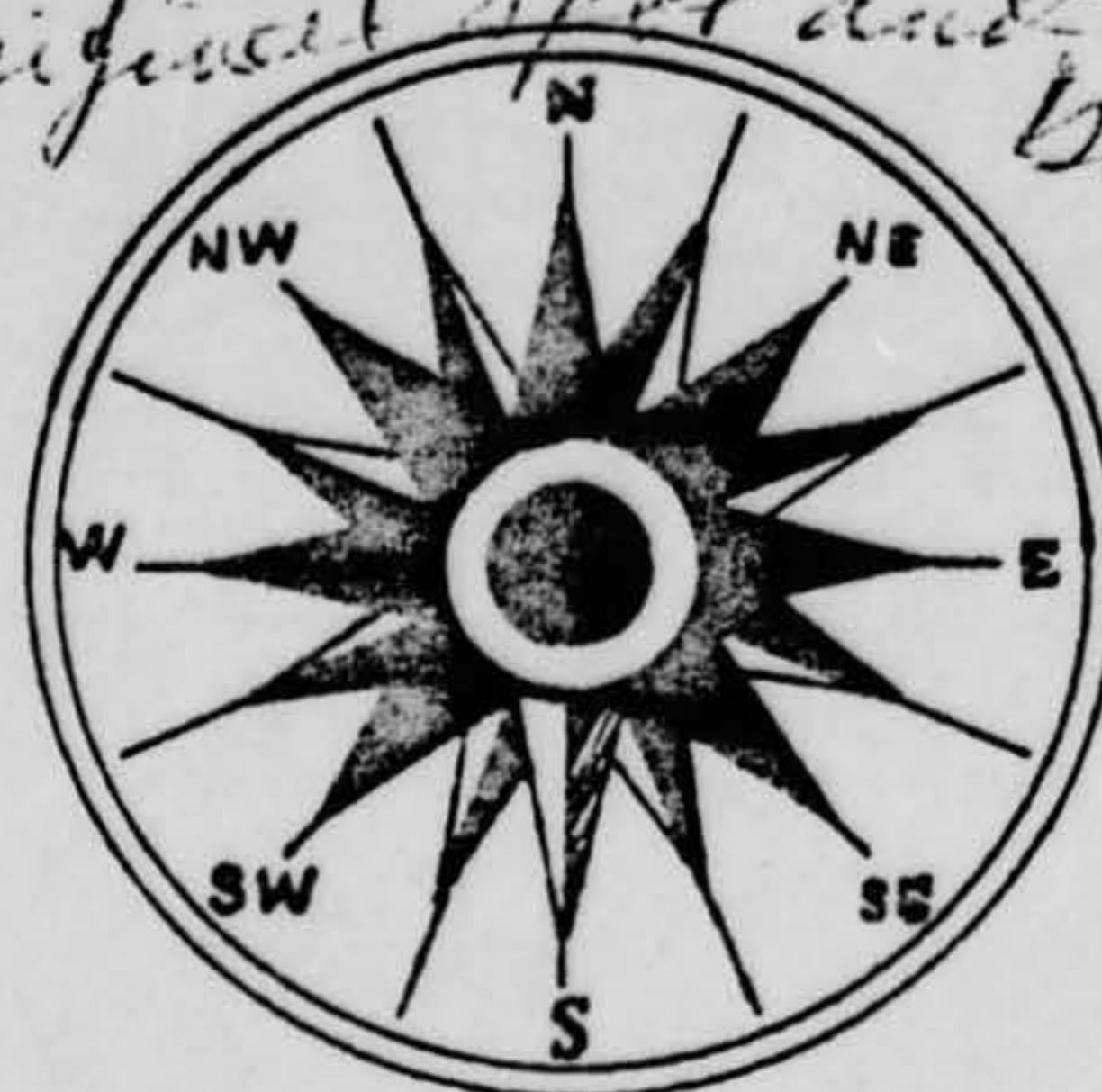
