Intersection of V34 and V249-483 is almost directly over the point of this sighting.

K. Position, title and comments of the preparing officer:

V34 would appear to run from NW quadrant toward the East (Mewburgh) from the point of sighting. Sighting could have been C-124 aircraft flying east on V34 toward Stewart AFB as this type of aircraft is new to the area and therefore strange. Also, it moves relatively slowly and would show red and green lights (flashing).
