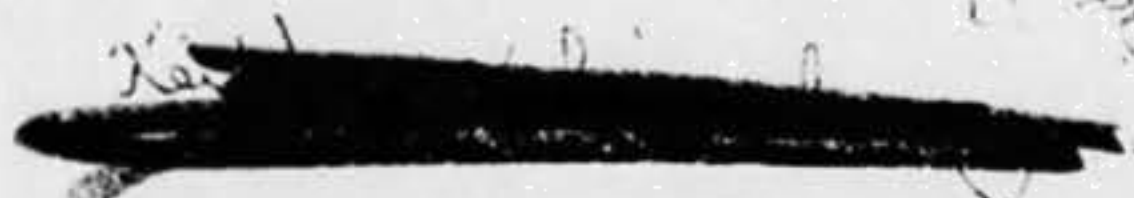
It had three red triangles

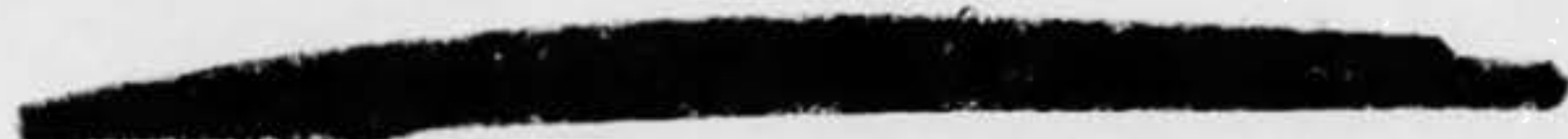
