Two Unidentified Flying Objects
Sighted in Irish Valley

There have been 2 Unidentified Flying Objects seen in the area of Irish Valley it is outside of Shamokin, Pennsylvania. This happened Tuesday January 15, 1967.

The two objects were flying, and described as saucer-shapes with red and green flashing lights and an antenna protruding out of the top. The two U. F. O's appeared at 6:00 P.M. E.S.T. traveling toward the west. As said by a lady the two split their course, one was very off to the side and the other traveling on a straight course along the mountain range. The lady called her mother's attention to the lights

which first appeared as bright light.
He said that as the objects approached,
there was clearer definition. On
the top of what appeared to be a
square shaped dome were several
silver devices one of which was
higher than the other and resembled
a radio antenna. Another man
had sighted it and obtained a pair
of binoculars from his home.
He said: No question about it,
it had an antenna on the top
and there was what seemed to
be a red tail fin on it. He said
that the device made no noise
but had a pulsating red glow
around it. He said that when
it began moving away, it
climbed at a terrific rate of
speed and disappeared within
minutes.
