Dear Sirs;

I feel that the information that I have should first come to you because it is you who investigate these matters.

On the night of Wednesday 15, February '67, I was looking out of one of our hall windows and saw an object which I will not say was a U.F.O. but it did have some strange characteristics. Below I have recorded the time, place, witnesses and a description.

Time: Between 9:25-9:30 P.M. Wed. 2/15/67

Place: In sky south-west of Chagrin Falls

(specifically- [redacted] Rd.
off route 422)

Witnesses: [redacted] (myself)

[redacted] (my father)

Description:

When I first saw "it", I thought to be a star, which seemed strange because it was the only star out that night. Remembering a few years back to the "Echo" (I think it was) I thought that it might be a weather balloon or something of that sort. After I observed it longer I noticed that it was moving in a westerly direction at a very slow speed, this took about 2-3 minutes. After about half a minute of remaining still, it reversed direction and went back in an easterly direction now flashing a red light equally as bright as the first. I then went into the other room and returned in about 2-3 (at most) minutes and noticed that it was gone. The peculiarity was that at its present speed, it could not have left my line of vision.

I was going to check with the airlines as to any flights in that area but I thought that I'd leave that up to you.

* Right here I would like to say that I don't think that it could have been an airplane because the lights it displayed were rather bright and radiating, not (I don't think) characteristic of an airplane.

Time: Between 9:25 - 10 P.M. Wed. 2/15/67

Place: In the south of Chapin Lake (specific [redacted])

Witnesses: [redacted]

Description: When first seen, thought to be a star (Wolfe appeared to be only star in sky). After observed longer, object moved in ^{2-3 min.} westerly direction. After 10-15 minutes, returned in easterly direction. Flasher red light equally as bright as white light. Went into observation room, returned in about 2-3 minutes and object gone. Peculiarity here because if speed, object could not have gone through in secondary line of direction to have same of view.

Could be black paint on airplane.

* Could not be plane because it displayed a very bright white light not observed in the airplane.
