The light was compared to a white light on a pole about one mile away. It was also brighter than the bright star in the western sky in the early evenings (Venus). In view of the fact that a KC-135 aircraft departed Blytheville AFB and was in the area, that the KC-135 aircraft has a record of causing this type of UFO report, and that the aircraft departed to the south would indicate that the witness could have seen this aircraft and reported it to be a UFO.

TWO AIRCRAFT FROM THE 97TH BOMBARDMENT WING BLYTHEVILLE AFB, ARKANSAS,
WERE IN THE VICINITY AT THE APPROXIMATE TIME OF THE SIGHTING. A
B-52G, CALL SIGN VALID 28 PILOTED BY LT COL WILLIAM F. LANE, TOOK
OFF FROM BLYTHEVILLE AFB TO THE SOUTH AT 110045Z MARCH 1967 ON A
WALNUT RIDGE DEPARTURE OUT OF THE BLYTHEVILLE AREA. A KC-135
CALL SIGN KELLY 45, PILOTED BY MAJOR D. A. BORNKESSEL, TOOK OFF
FROM BLYTHEVILLE AFB TO THE SOUTH AT 110122Z MARCH 1967 ON A BARLOW
DEPARTURE OUT OF THE BLYTHEVILLE AREA. THE AIRCRAFT WOULD HAVE MADE
A RIGHT AND LEFT TURN, RESPECTIVELY, WITHIN 12 NM AND BOTH WOULD
HAVE BEEN IN THE OSCEOLA AREA AT THE APPROXIMATE TIME OF THE SIGHT-
ING. OSCEOLA IS APPROXIMATELY 18 STATUTE MILES SOUTH OF BLYTHEVILLE
AFB. PARA 14K(KILO): CHIEF, INTELLIGENCE DIVISION, 97TH BOMBARDMENT
WING, BLYTHEVILLE AFB, ARKANSAS, 72315. COMMENTS: THE MOST LOGICAL
EXPLANATION OF THIS SIGHTING IS THAT THE OBSERVER SAW THE KC-135
WHICH DEPARTED BLYTHEVILLE AFB AT APPROXIMATELY 110122Z. THE KC-135
IS EQUIPPED WITH TWO POWERFUL FLOOD LIGHTS WHICH ILLUMINATE THE WINGS

WHEN TURNED ON AND APPEAR TO BE A ROUND BRILLIANT WHITE LIGHT WHEN
OBSERVED. REPORTING OFFICIAL HAS OBSERVED THIS PHENOMENON FROM A
DISTANCE OF APPROXIMATELY ON-HALF MILE AT BLYTHEVILLE AFB DURING
THE EVENING HOURS. THERE IS NO SPECIFIC TIME THAT THE FLOOD LIGHT

IS TURNED ON BUT RATHER AS THE CREW DESIRES, EVEN DURING TAKE-OFF.
THIS IS THE THIRD TIME THAT A KC-135 HAS BEEN SUSPECTED OF BEING
THE CAUSE OF A UFO SIGHTING. THE B-52G IS NOT SO EQUIPPED AND HAS
NOT BEEN SUSPECTED OF CAUSING A REPORT OF THIS TYPE. IN VIEW OF
THE FACT THAT A KC-135 WAS IN THE OSCEOLA AREA AT APPROXIMATELY
THE TIME OF SIGHTING, THAT THE KC-135 HAS A RECORD OF CAUSING THIS
TYPE REPORT, THAT THE INSTRUMENT DEPARTURES TO THE SOUTH ALWAYS
PLACES JET AIRCRAFT IN THE VICINITY OF OSCEOLA WITHIN APPROXIMATELY
THREE MINUTES, THE MOST LOGICAL CONCLUSION AS TO THE CAUSE OF THIS
SIGHTING IS THAT THE OBSERVER SAW THE KC-135 DURING DEPARTURE
FROM BLYTHEVILLE AFB. PARA 14L(LIMA): NONE. A TAPE RECORDING OF
