- e. Lens opening used; that is, "f" stop.
- f. Filters used.
- g. Was tripod or solid stand used.
- h. Was "panning" used.

i. Exact direction camera was pointing with relation to true North, and its angle with respect to the ground.

2. If supplemental information is unobtainable, the minimum camera data required are the type of camera, and the smallest and largest "f" stop and shutter speed readings of the camera.

3. Upon receipt of the above information and your negatives a comprehensive photographic investigation will be undertaken.

4. Upon completion of the analysis we will return your negatives along with our findings.

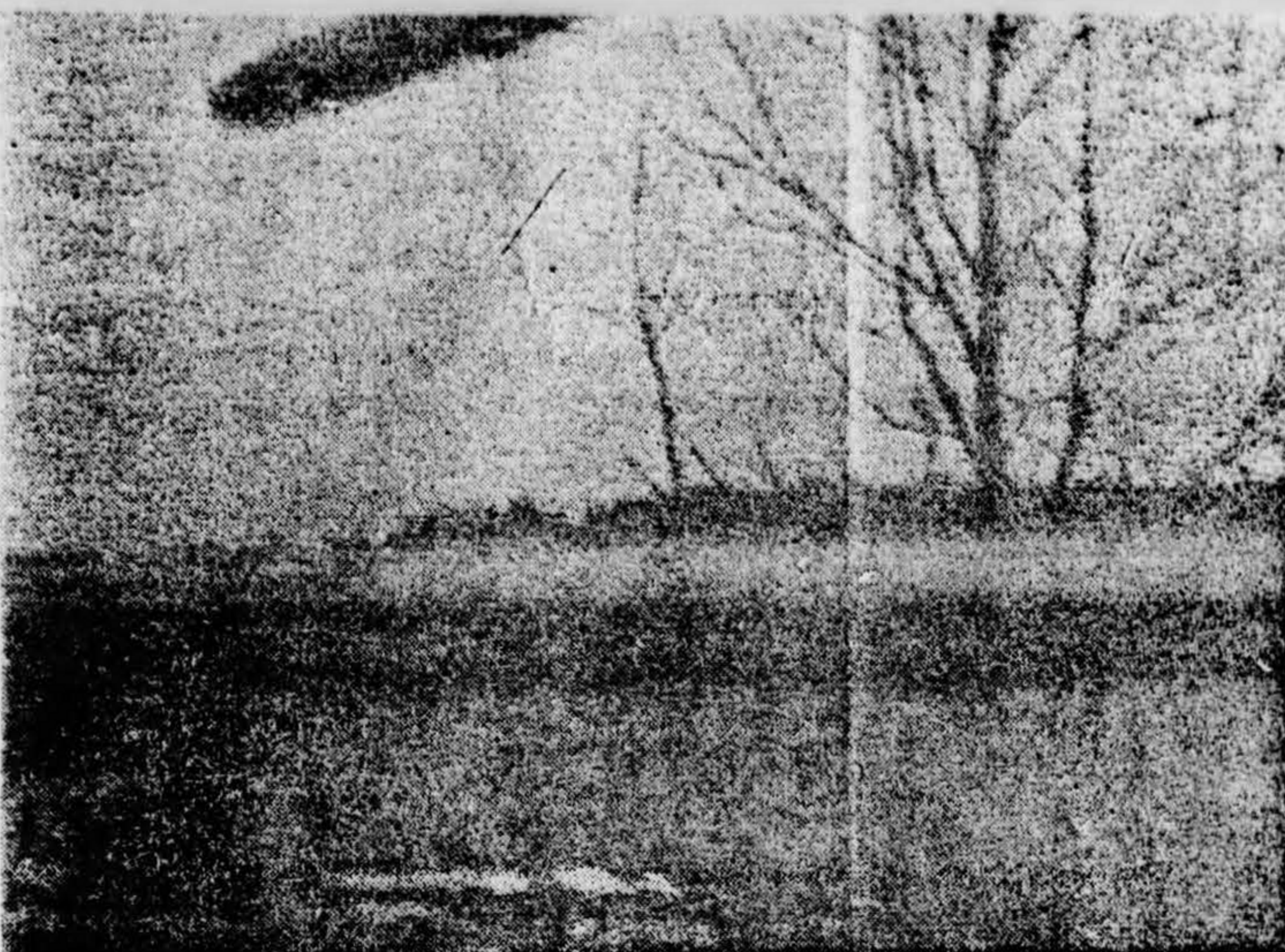

FLYING SAUCER IN ROCHESTER — OR WHAT?

Pictures Taken by Mark Hrabetz, 12, Through Living Room Window



Local Lad Photographs A Nearby Flying Object

"I don't really believe in flying saucers from another planet, but I suppose its possible."

Mark Hrubetz, 12, son of Mr. and Mrs. D.L. Hrubetz, 1948 3rd Ave. NE, made this remark after taking the pictures that accompany this article.

They are the first reported pictures taken in the Rochester area of what appears to be a flying saucer. He took them March 12.

Mark said he looked out his living room window to see if the paperboy was coming, but instead saw a flying saucer-like object hovering over the roof of the apartment building across the street from the Hrubetz home.

It was silver-colored and black around the outside edge, he said. A cloth or plastic-like material fluttered from the top of the stack in the center of the object, Mark said.

"I was awfully scared because it was so low," he said. It looked to him to be about the size of a car.

He raced out to the kitchen, got his camera and took three pictures of the round object before it lifted up out of sight. It was in view for only about 45 sec-

about 9:15 on a Sunday morning, and Mark was the only member of the family who was up at the time. His parents did not see the object, and he doesn't know of any neighbors who may have seen it.

"We thought Mark was seeing things when he told us," Mrs. Hrubetz said, "and were really shocked when the pictures came back from the developers."

The object was over the apartment when he first saw it, but moved over the street by the time he took the pictures, he said. His camera was a "little cheap one he won in a contest."

The circular object "tilted or wobbled back and forth" as it moved, and then "shot up" at an angle out of sight, Mark said.
