Dear sirs,

I am only twelve years old but what I saw April 25, just might be an unidentified flying object.

My father and I were over the neighbors talking with a new friend. We were talking about fifteen minutes and walked home. It was getting dark and we went to put the truck away, when we came out of the barn.

I looked toward the mountain (which was far away and hidden by trees) and saw the red light of the radio station. But I saw another red light just above the trees, and it was moving at a fair rate of speed. When I saw it I ran as fast my feet would carry me to get the field-glasses. When I returned it was nowhere in sight and I had not even been gone for half a minute. I looked way to the right and there it was, going at the same speed, but I never saw anything change a flight path so quickly and be so far away from where it had been before! I looked at it through the field-glasses and it was a blinking red light with no shape. When the red light blinked off the color was blue in the same place. It started to go behind some trees so I couldn't see it. I ran down the hill to a better view point but it was just gone.

When I got back up the hill there was another light, orange in color and moving twice as slow as the first light. When it got behind the trees it disappeared too. I stayed outside for about ten minutes but I could not see them anymore. I don't know exactly what I saw but I would be grateful if you wrote back.

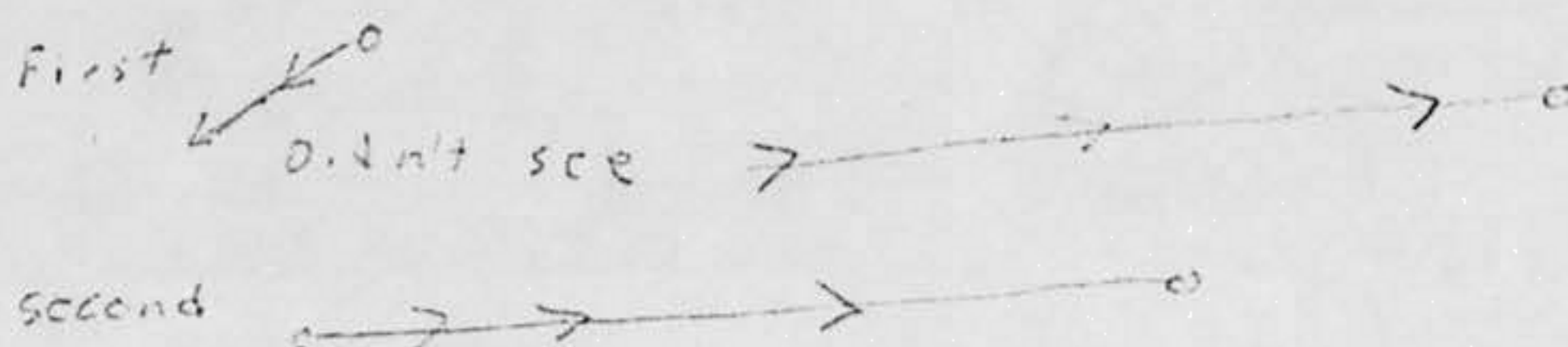
