1. COLOR: Flashing red and white with some blue.
2. Had left a trail of exhaust behind it.
3. Was oblong or like a flat disc.
4. They moved at a fast pace.
5. Was first sighted in the N.W., then in the WEST, then in S.W. and then stayed in the south like it was hovering over something or waiting for --stayed-- something. IT was about 12 miles up in the air and stayed there for about an hour or more. AND as far as we know it was still there after 1:00am in the morning.

With a pair of binoculars and a telescope saw the UFO's. Things were coming in and out of it as if were a mother ship. The things looked like smaller ships. We saw these ships coming and going about every 5 or 10 minutes like they were loading something on the mother ship. When the UFO's were in between the N.W. and the S.W. section of the sky there were two other UFO's one was smaller and was an oblong shaped (red-light) craft which looked as if entered the larger one.

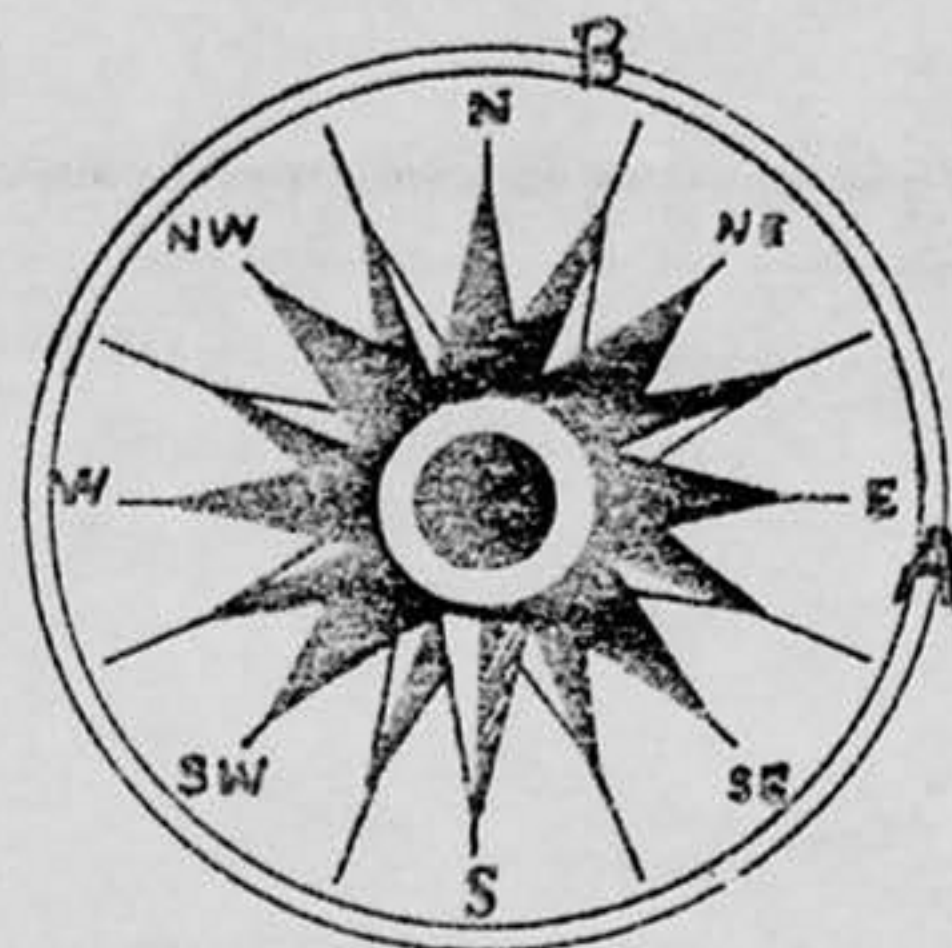
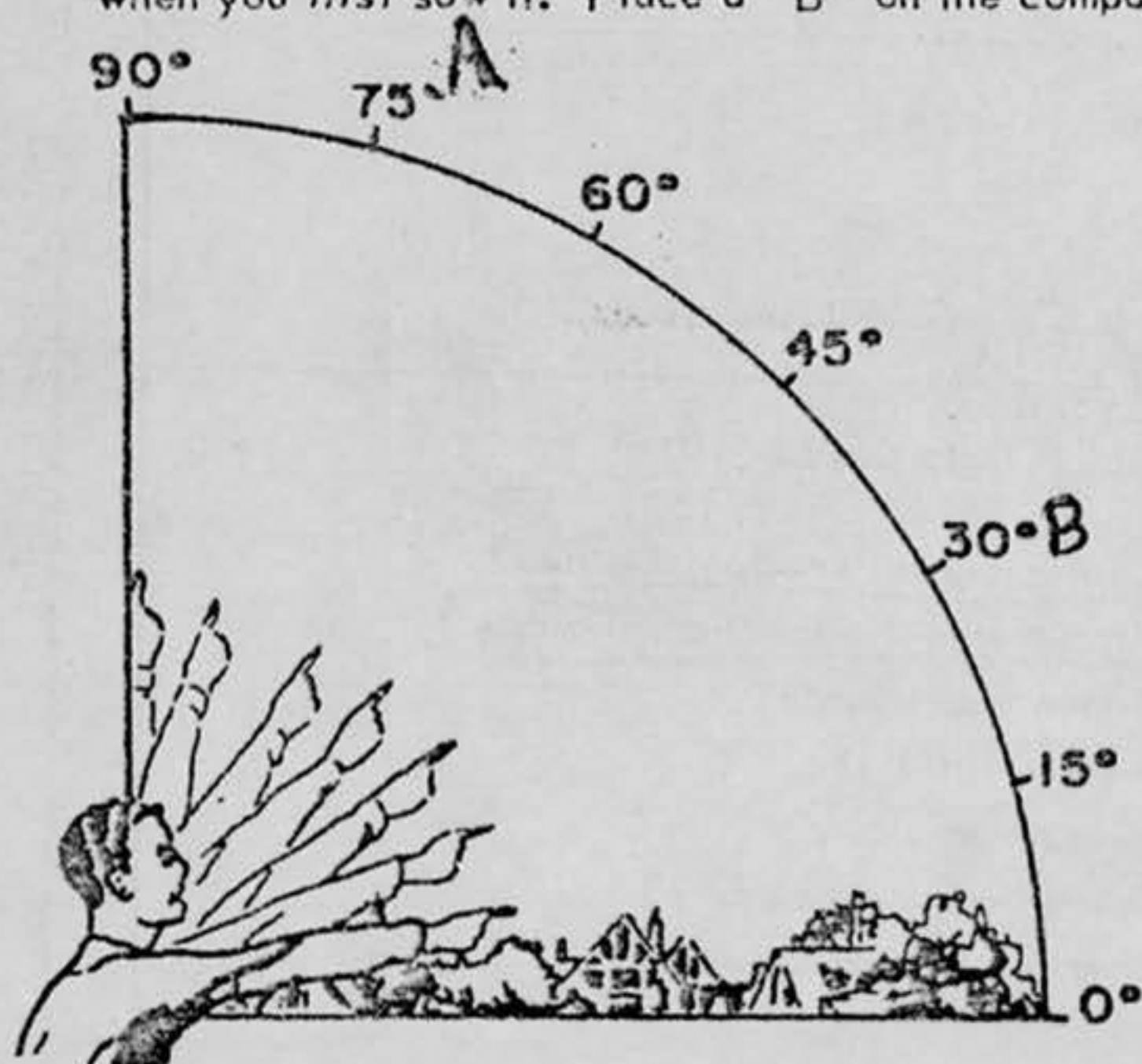
