Sighting of ~~UFO~~ 2 July 67

Rec at TDPT/UFO in Jan 68

At 3:00 P.M. Central Daylight time, on July 2, 1967 I was watching a baseball game at the Fenway Stadium in St. Paul, Minnesota. It was a cloudy - partly cloudy day, with ~~rain~~ clouds, scattered with alto-cumulus. I was thinking of how I had read that bright lights, like those there, could produce after-images in the eye. I was testing this; and it worked with only faint images. These disappearing, I looked back. I saw a fighter jet go over just south ~~west~~ of the field. Excited by my thinking of UFOs, I looked up and found I was looking at a flying saucer over the ~~press~~ box west of the ballpark. Watching it fly SW to NE ~~about~~ about like the speed of a prop airplane at that height. It passed over the lights (always at a constant speed, not moving with my eyes) and toward the low cloud. I just barely went over the cloud and was obscured to me for its journey across the cloud, about 3 sec. It came out and then climbed very fast, disappearing into the heavens. I was so absorbed in it I didn't call my cousin's attention to it, and I should have. The others didn't believe it, but my mother did, since she doesn't doubt my honesty and believes in UFOs, like ~~me~~ I do.

It was bright metallic in color and was not an afterimage of the field lights, since I ~~had~~ had tested this. It was definitely round.

a balloon, but weather stations don't launch them at 3:00. (I don't think...?)

It was moving against the wind, which was a north wind.

While moving laterally it was also viewed from side. When it ascended, it tilted upward to get a bottom view.

There was no sound. There were 2 cloud layers. It went over the upper one which was almost non-moving. The lower clouds were very fast.

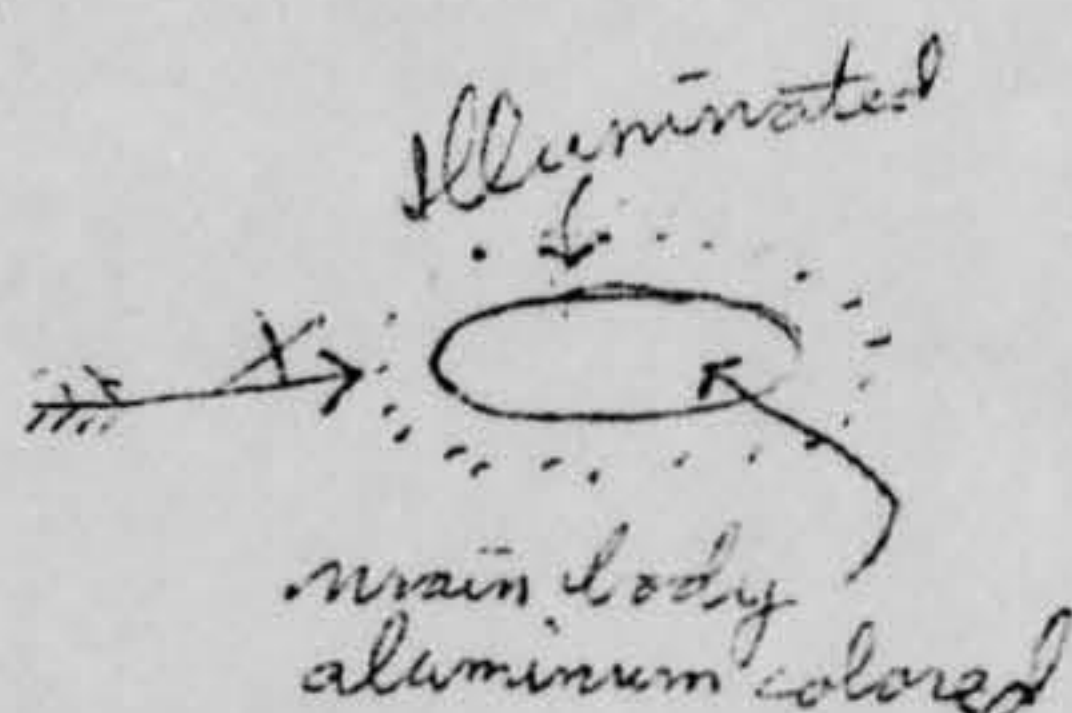
The last time I wrote you I mentioned a couple of sightings.

Selander was under it and it looked like a saucer to him. I was on the highest point of the county road in this neighborhood. A few stars... moon was overhead... it was about 10:30 p.m. It looked like aluminum as if a flood light was turned on it. The space around it was sort of illuminated same shape as the main body of the UFO (to the dots in illustration marked "x") It traveled north, no noise.
