2. While reviewing our correspondence files we found your letter in which you reported seeing an unidentified object on 5 September 1967. Because of an error, your sighting was not investigated at that time. We handle over 10,000 letters and investigate approximately 1,000 UFO sightings a year; once in a while an error is made. We regret that this has kept us from investigating your observation. However, if you would complete the inclosed AF Form 117 we will investigate your sighting in an attempt to determine the stimulus for your observation.
3. Thank you for reporting your observation to the Air Force, once again, please excuse us for not responding to your correspondence earlier.
