1. The Aerial Phenomena Office is in receipt of two different unidentified flying object reports from the Indianapolis area.
2. On the evening of 31 July 1967, one observer saw an object, that when best described by ordinary objects, looked like two connected white illuminated rolls of toilet tissue. These were connected so that when looking at the object, from directly underneath, it would look similar to the end of a pair of binoculars.
3. We also received a report from the morning of 6 September 1967 in which another observer sighted a white saucer shaped craft that was flat on the top and bottom.
4. If you were in the area on or about these days, or if you know what may have been the cause for the sightings, we would appreciate your letting us know.
5. Thank you for any assistance that you can provide in helping us to solve these two cases.

1. The Aerial Phenomena Branch is in receipt of an unidentified flying object report which was observed a few miles north northwest of downtown Indianapolis on 6 September 1967 at 0630 EST. The observer described the object as saucer shaped and comparable in size to a conventional aircraft.
2. We have received similar descriptions of aerial advertising planes in the past. If there were any advertising planes in the area or if you have any knowledge of a possible cause for this sighting the information would be helpful in our investigation.
3. Names and addresses of any person or company operating advertising planes in your area would be useful in our investigation of UFO reports. Thank you for your assistance.
