questionnaire or a narrative explanation of your sighting. ON 2-20-68, WE WERE PROCEEDING SOUTH ON RT. 95, WHEN AT APPROX. 8:30 P.M., WE SMELLED A STRONG ODOR WHICH WE DID NOT RECOGNIZE. I ASSUMED IT WAS THE CAR SO, PULLED OFF AT NEXT RAMP, STOPPED AT GAS STATION, CHECKED CAR THOROUGHLY BUT FOUND NOTHING WRONG AND ODOR HAD DISAPPEARED. ATTEMPTED TO GET BACK ON RT. 95, BUT WAS QUITE CONFUSED AND FOUND MYSELF GOING SOUTH ON 301. SHORTLY, NOT SURE HOW LONG MY WIFE AND CHILDREN SAW FLASHING RED LIGHT APPROX. $\frac{1}{4}$ TO $\frac{1}{2}$ MILE WEST OF US AND MAYBE ~~25~~ HUNDRED FEET OFF GROUND, PACING US. WHILE THEY WERE WATCHING THIS LIGHT, I SAW WHAT I THOUGHT WAS THE TOP OF A LARGE TOWER AHEAD OF US AND DIRECTLY IN FRONT OF AND AT SAME HEIGHT AS LIGHT PACING US. WHEN BOTH THE LIGHT PACING US AND CAR WERE OPPOSITE TOWER, SMALLER FLASHING RED LIGHT STOPPED NEXT TO TOWER. THEN, TOWER SLOWLY MOVED TOWARD US, BANKING + DROPPING AND PASSED OVER CAR. I HAD MY LEFT EAR OUT WINDOW BUT COULD HEAR NOTHING + THERE WAS NO WIND. I THOUGHT TOWER WAS GOING TO HIT US, SO HAD PULLED CAR OFF TO RIGHT SIDE OF ROAD AND ALMOST BUT NOT QUITE STOPPED. WE THEN WENT OVER RAILROAD TRACKS. WE IMMEDIATELY PROCEEDED ON AND GOT BACK ON RT. 95 AT NEXT RAMP, WHILE PULLING BACK ON RT. 95 AND FOR A FEW MINUTES AFTERWARDS, WE SAW TWO (2) SMALL FLASHING RED LIGHTS DOING A JIG UP IN THE SKY, BACK AND TO THE EAST OF RT. 95. THIS PERFORMANCE WAS THE SAME ONE AS MY WIFE AND I WATCHED ON 1-12-68.

THE NEXT NIGHT, 2-21-68 AT JUST ABOUT THE SAME TIME WE WERE ON RT. 301 HEADING TOWARDS SARASOTA, FLA. AND I WOULD GUESS APPROX. 150 MILES FROM SARASOTA AS WE ARRIVED IN SARASOTA AT MIDNIGHT WHEN I SAW IN MY REAR VIEW MIRROR, A RED LIGHT (NOT FLASHING) THE SAME AS ONE OF THE RED LIGHTS ON THE BIG OBJECT WE SAW THE NIGHT BEFORE. IT WAS PROBABLY 50 TO 100 FEET BEHIND THE CAR AND TO MY SIDE IN THE MIRROR SO, IT MUST HAVE BEEN DIRECTLY OVER THE CENTER OF THE ROAD. IT DID NOT LIGHT UP THE PAVEMENT. IT WAS BEHIND US FOR MAYBE 10 MIN. AND WAS GONE WHEN WE ENTERED NEXT SMALL TOWN. FOR FEAR OF PANIC, I DID NOT TELL THE OTHERS ABOUT IT. I STOPPED AT A STORE, INQUIRED ABOUT MOTELS, (THERE WEREN'T ANY), THEN PROCEEDED ON. IT WAS 9 P.M.

AROUND MAYBE 11 P.M., WE WERE STILL ON RT. 301 NEAR THE OUTSKIRTS OF TAMPA WHEN MY WIFE NOTICED A FLASHING RED LIGHT UP HIGH AND TO OUR LEFT. IT MOVED TO OUR RIGHT AND WHEN IT WAS DIRECTLY IN FRONT OF US AND IN LINE WITH THE ROAD, IT CAME TOWARDS US AND SLOWLY DESCENDED. WHEN IT WAS MAYBE $\frac{1}{2}$ MILE FROM US AND MAYBE 30' OFF ROAD, IT SUDDENLY SHOT OFF TO OUR RIGHT. THERE WAS OTHER TRAFFIC ON THE ROAD AND WE JOKINGLY COMMENTED THAT HE WAS A DISSEY.

Dear Sir,

Enclosed find reports on UFO'S. I honestly thought that the NICAP might be a front for the Government, so on my recent trip down, I stopped and gave them an oral report which I forbade them to publish but lost all confidence in them when I felt they told me an untruth.

As you probably already know, I received quite a run-around in Fayetteville and am grateful to Mr. Vincell, the CID man for finally breaking down.

At the time, those incidents seemed excitingly interesting and it wasn't till we had returned home and slowed down a bit that they began to bother me to the point where I had to be sure that the right people, whoever they were, knew about them. I did make an attempt at reporting them on our return home by stopping at a State Trooper's barracks but I couldn't get anyone to answer the doors.

The questions that plague me today are these;

Why were we approached, personally, twice and maybe a third time at such a distance from one another? If it was just by chance, there would have to be an enormous number of these things around and then the odds would be against it considering the great number of cars on the road. I believe that it was personal and in trying to figure out why we were approached, have come to the conclusion that the difference between us and the majority of other cars on the road at that time are as follows;

We were young people where, I would imagine, the majority of other cars contained older people (Florida tourists),

We didn't panic, show great fear, run to the police, etc. In other words we just kept going, but if I had had any idea that we would have again ended up on lonely stretches of road the following night, we would have stopped at dusk. As it was, we arrived in Sarasota at midnight, were informed that there wasn't a room in the state of Florida and ended up sleeping in the car.

Our oldest girl is a diabetic and we would give her a shot of insulin around 3 or 9 every night.

I would like, if possible, to discuss this further with someone who has knowledge of the patterns, if any, these objects follow on their close approaches to humans, possible after-effects of a close approach, etc. Being self-employed, my time is my own and I would be willing to go any reasonable distance to talk to someone.

In reference to the 1967 and Jan. 1968 incidents, I don't know of anyone around here who might be interested in them except the newspapers so, unless they mean something to you, you can throw them away as far as I'm concerned.

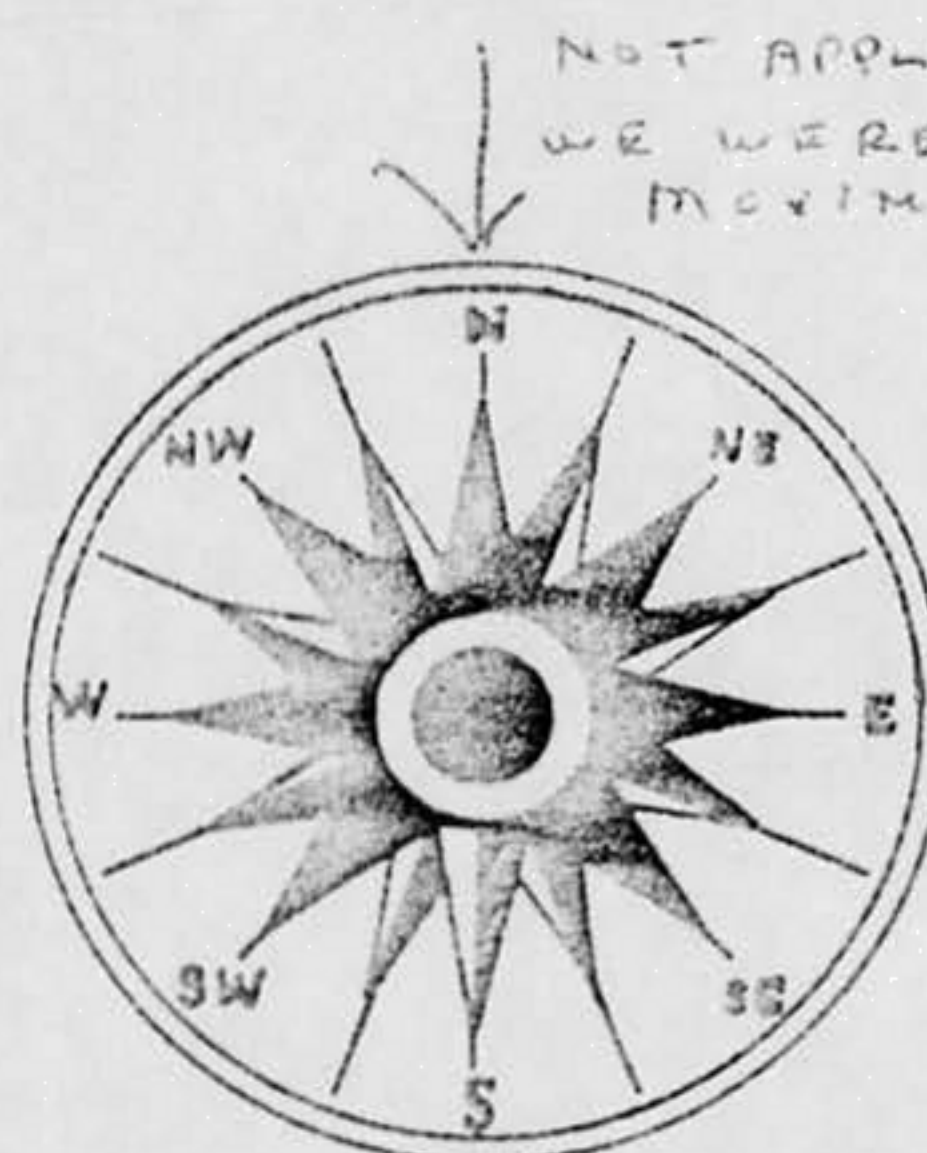
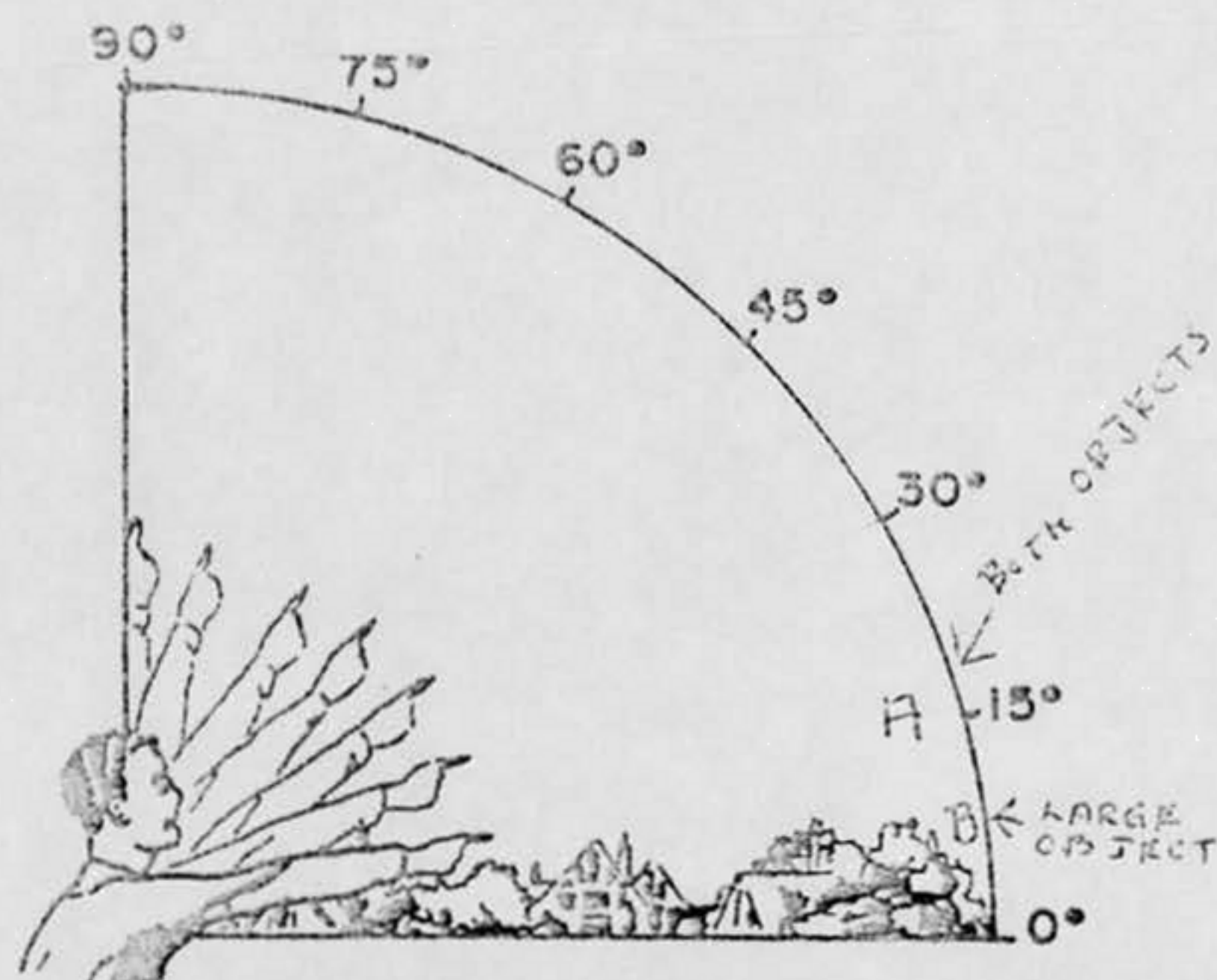

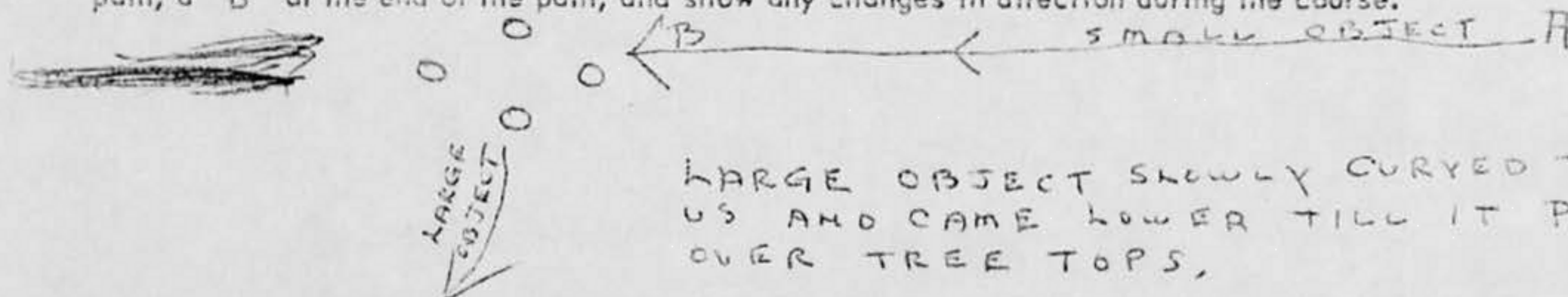
