I saw some stars and then turned in the opposite direction to go inside (around the driveway and thru entrance) to my home. 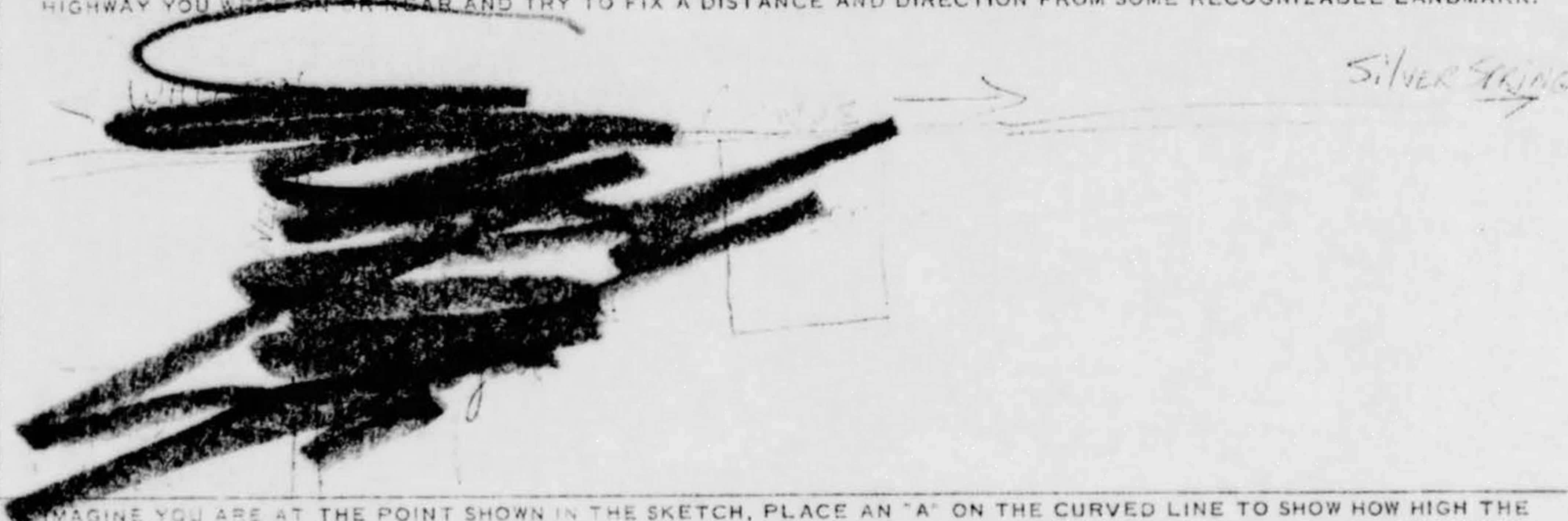

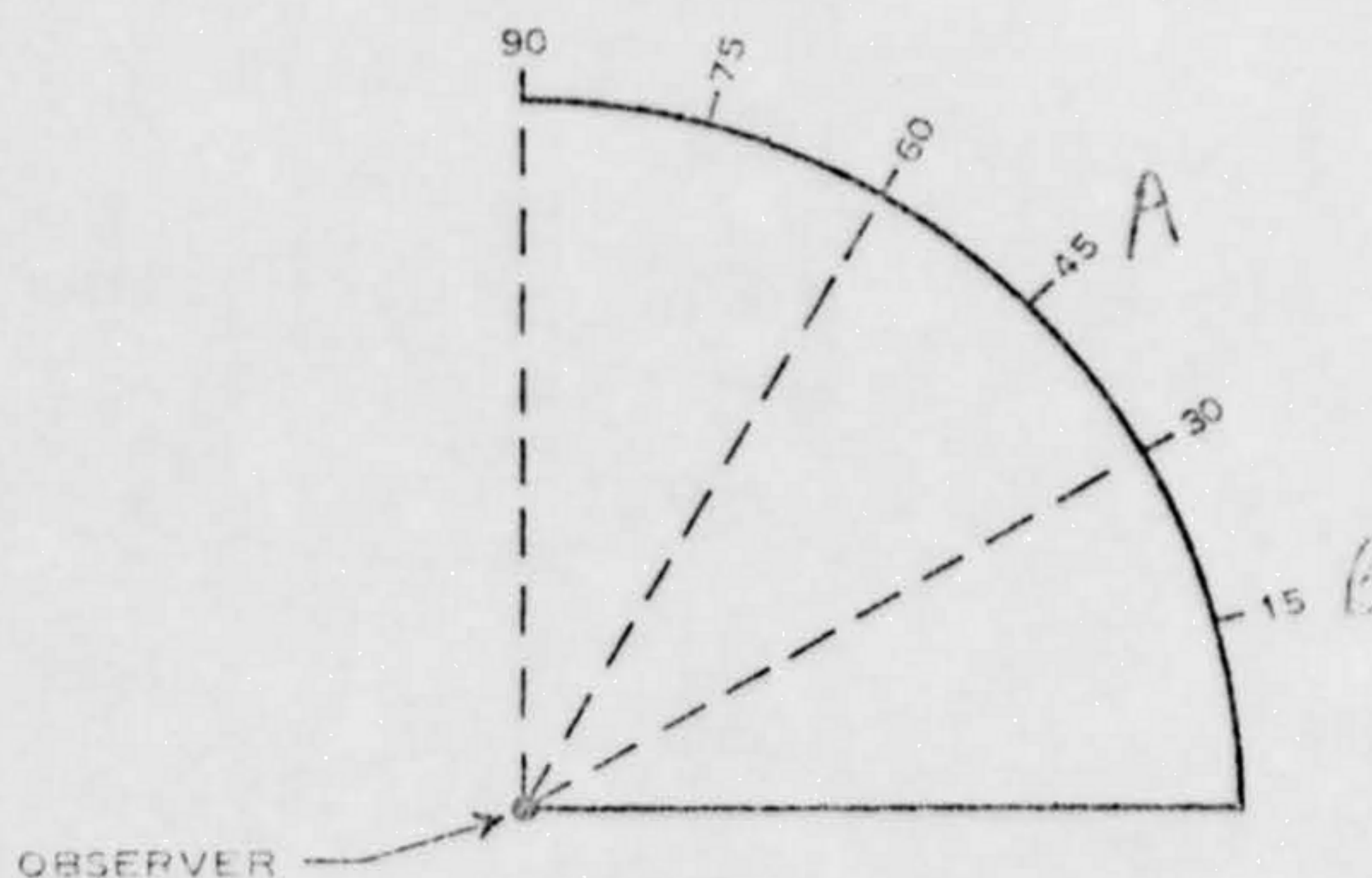

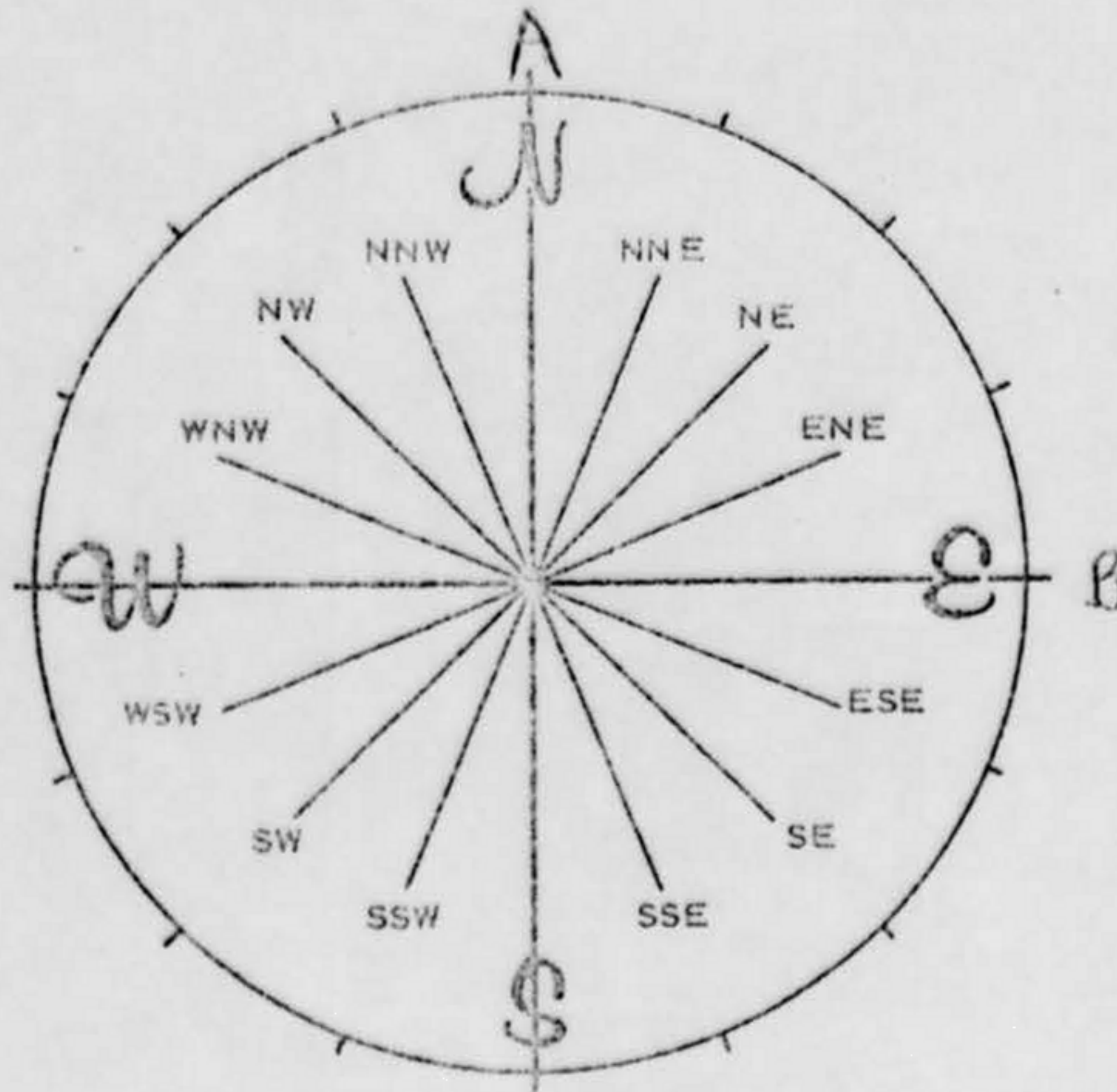

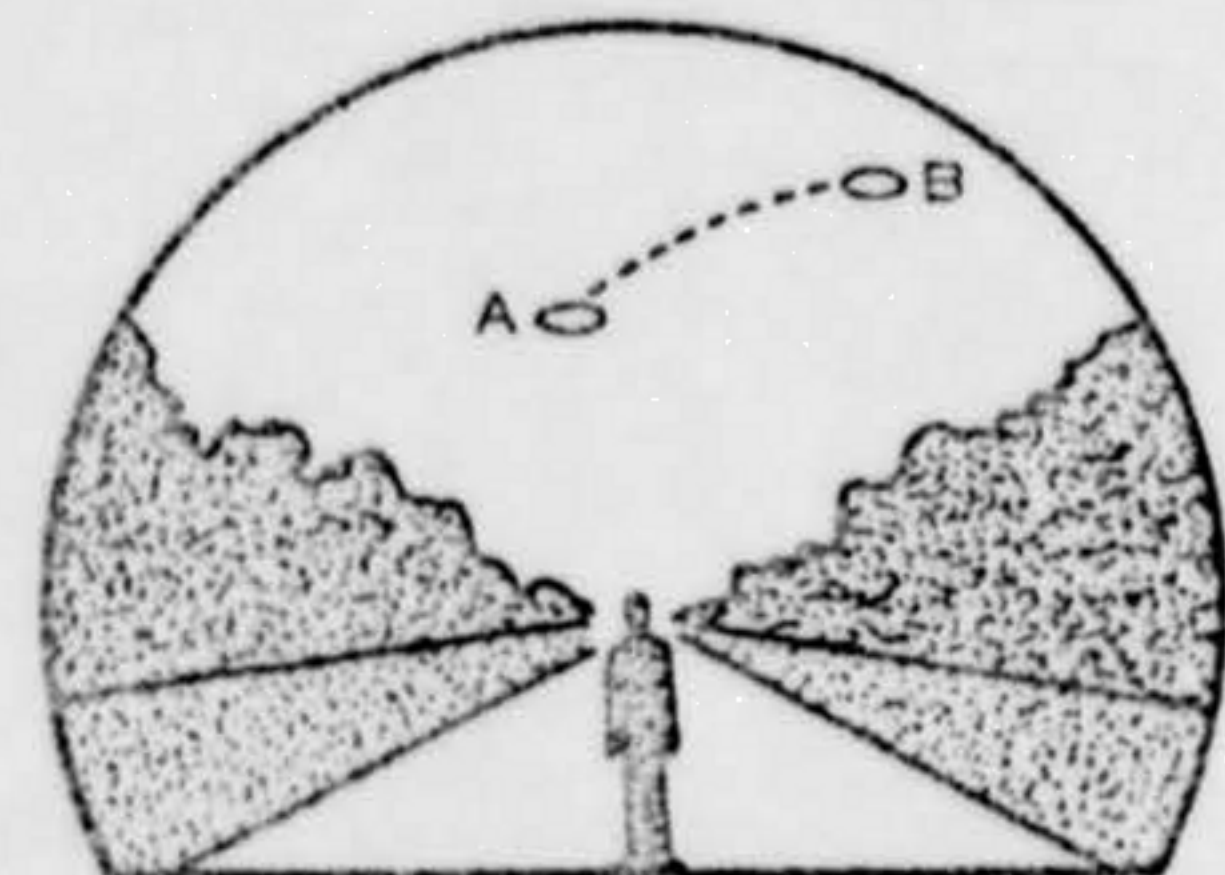
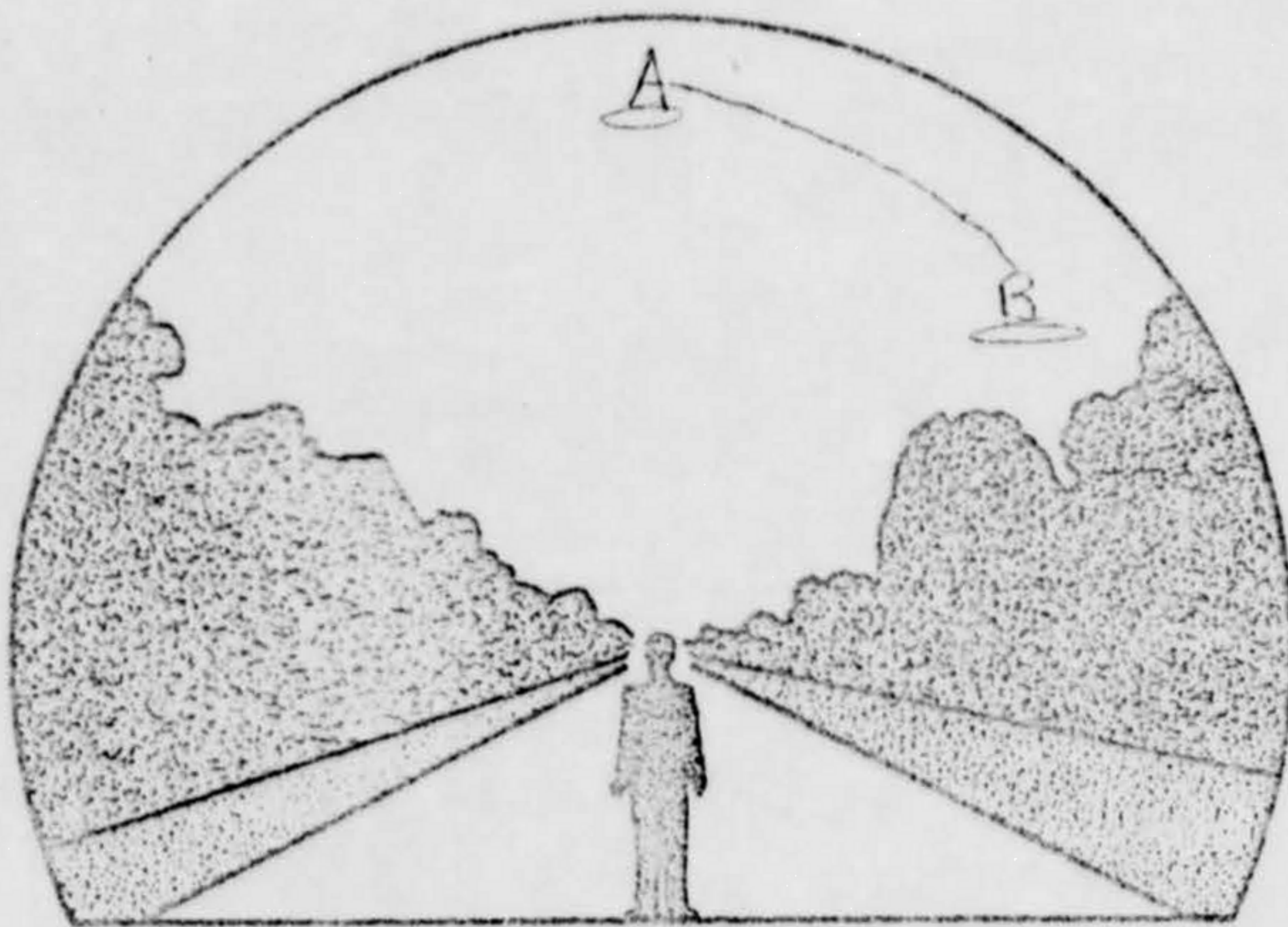
