The boats radar lit up then popped out. COMMENTS: A nearly full moon was at an azimuth of 241° and 5° elevation at the time of the sighting and probably accounts for the visual sighting. There is insufficient data to determine the cause of the radar malfunction. An AF Fm 117 was sent to the observer on 28 Aug 69 but has not been returned as of 13 Nov 69.

SUBJECT: UFO Observation, 26 Aug 69

1. On 23 Aug 69, TDPT (UFO) was called by Gen. Smith's office, Chicago Air National Guard. They stated that Mr. [REDACTED] had reported a UFO observation to their office. The Air National Guard gave Col. Quintanilla the following information about Mr. Bederman:

2. Col. Quintanilla called Mr. Bederman and received the following information about the observation:

Observers: Mr. [REDACTED] Captain and First Mate

Date: 26 Aug 69

Time: 0400 hours

Location: Algoma, Wisconsin (about 7 mi off the coast south of Sturgeon, Wisconsin)

Direction: Boat was heading north, object was to the west of the boat.

Description: The captain and first mate were on the bridge. They saw a bright light. The light hovered over the boat, disappeared, then reappeared. (There was a low cloud base, and the object would disappear when it lifted up.) The boat's radar lit up then popped out. The object was brilliant orange and had a tail. It was shaped like half of a watermelon.
