ONTARIO. BOTH PIECES REPORTEDLY WERE SHIPPED TO DR. LEGER AT THE DIRECTORATE GENERAL OF INTELLIGENCE AND SECURITY/DIRECTORATE OF SCIENTIFIC AND TECHNOLOGICAL INTELLIGENCE, IN OTTAWA.

2. THESE TWO PIECES MAY BE FROM A NON-US SATELLITE AND WOULD BE OF INTEREST TO USAF FOREIGN TECHNOLOGY DIVISION AT WRIGHT-PATTERSON AIR FORCE BASE IN OHIO AND TO CIA'S OFFICE OF WEAPONS INTELLIGENCE. POST IS REQUESTED, IN ACCORDANCE WITH REF C, TO OBTAIN DETAILED PHOTOGRAPHIC COVERAGE OF THESE OBJECTS. POST IS FURTHER REQUESTED TO OBTAIN FULL REPORTS OF ALL EXAMINATIONS MADE OF THESE PIECES BY CANADIAN AUTHORITIES.

3. FTD HAS EXPRESSED POSSIBLE INTEREST IN PARTICIPATING IN EXAMINATION OF OBJECTS. POST IS REQUESTED TO ASSESS POSSIBILITY OF SUCH PARTICIPATION AND INFORM DEPARTMENT.

4. POST IS FURTHER REQUESTED TO REPORT INFORMATION AS REQUIRED BY REF C. ROBINSON
