Dear sir of B. L. L. L. L.,

On March 30, 1967 between 7:10 & 8:45 P.M.
I was watching a strange light that grew & grew
brighter until it was disc shaped and a rainbow
color. At first I thought it was the moon shining
through the clouds and thought nothing of it until
a second ~~one appeared~~ and smaller one appeared
lower and to the right. While that one was growing
brighter, the first one was fading to a pale blue
against the dark, night sky. I rushed home to get my
camera and bulbs. When I got outside again my
friends said another very small one appeared lower
and to the left. The second one faded to a pale blue
while the third one turned brown and disappeared
while the other two kept fading. I took 3 pictures.
One without the flash, all and two with the flash.
I am not sure at the time whether they came out or
not.

At 8:45 P.M. the U.F.O.'s finally faded completely
away. The second one faded away before the first one faded
away.
